


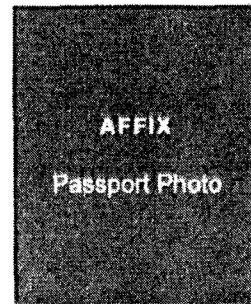

7. **Modification of the title of the thesis :**


