

ADMISSION TO TWO YEAR CERTIFICATE COURSE, SANGIT-BAHVANA

Applications in prescribed form are invited for Admission to Two Year Certificate Course for the year of 2017-2018

➤ Prescribed application forms may be obtained from Sangit-Bhavana Office on production of a Cash Coupon (Rs. 500/- for General/OBC candidates and Rs.150/- for SC/ST/PWD) candidates to be procured from the Accounts Office, Visva-Bharati.

Applications forms may also be downloaded from the University website (www.visva-bharati.ac.in) and in such case, a Demand Draft of Rs. 500/- for General/OBC candidates and Rs. 150/- for SC/ST/PWD candidates issued in favour of "ACCOUNTS OFFICER, VISVA-BHARATI" drawn on State Bank of India, Santiniketan (Code: 2121) must be attached with the filled-up application form.

The candidates should attach self-attested photocopies of (i) Marksheets & Certificates of all previous public examinations, (ii) Birth certificate, (iii) Proof of residence, (iv) Caste certificate, (v) PWD certificate, (vi) Family Income certificate, (vii) Two passport-size recent photo of the candidate.

- Period of issuance of form: 5th August to 29th August, 2017.
- > The form duly filled up with necessary enclosures should be submitted to the office of the Principal, Sangit-Bhavana. The last date of submission of completed form is 29th August, 2017 (Tuesday) upto 4:00 P.M.
- > Date of Admission Test: 10th September, 2017 (Sunday) at 9:00 A.M.
- Venue of Admission Test: <u>Sangit-Bhavana</u>, <u>Visva-Bharati</u>.

SUBJECTS: (1) RABINDRA SANGIT, (2) MANIPURI DANCE, (3) KATHAKALI DANCE,

- (4) RABINDRA NRITYA, (5) HINDUSTANI CLASSICAL MUSIC (VOCAL),
- (6) SITAR, (7) ESRAJ & (8) TABLA.

Note: Those who have applied earlier in 2017 through online mode need not apply again. Their applications will also be considered, subject to satisfying prescribed conditions of eligibility. No call letter will be issued for this purpose.

Since the Two Year Certificate Course is a Part-time Casual Course, students admitted to such course shall be treated as "CASUAL STUDENTS". They will be entitled to restricted Library facility and they shall not enjoy other facilities normally extended to the regular full-time students of this University. A regular full-time student, opting for a part-time Music & Dance Course, also will not be entitled to extra library facility.

Eligibility: (1) Madhyamik or passed equivalent examination.

- (2) Staff, Staff-ward and Students of Visva-Bharati.
- (3) Residents living within the radius of 8 (Eight) K.M. of Visva-Bharati.

Those candidates who are not the staff and students of Visva-Bharati applying for admission must produce a Certificate from the Chairman of the Municipality, Pradhan of the Gram Panchayet together with current Ration Card or other Residential proof like Voter Identity Card, Electricity Bill, Driving Licence, etc.

(i) Age Certificate, (ii) Leaving Certificate from the School, College, Institute or the Board last attended, (iii) Attested copies of marksheets of all previous public examinations, (iv) Certificate from a respectable person who knows the candidate personally certifying his/her character, (v) Pass certificates of all previous public examinations, (vi) Migration Certificate (where applicable), (vii) *Income Certificate.

The application will not be entertained if the above enclosures are not attached with it. However, if the pass certificate of the previous examination and the Migration Certificate can not be produced at the time of admission due to non-availability, the same must be produced within THREE MONTHS from the date of admission, otherwise the admission will be treated as cancelled.

(c) In the case of an OBC candidate, the onus of proving that he/she does not belong to the 'creamy layer', shall rest with the candidate. Accordingly, OBC candidates are advised to enclose appropriate certificates in this regard as per relevant directives of the Government of India.

*The income certificate of the guardian must be certified by (i) a Gazetted officer or (ii) the Employing Authority or (iii) the local authority (B.D.O./Panchayat Pradhan/Head of the Institution last attended/Chairman, Municipality).
