National Seminar on Prevention of Violence against Children: Challenges and Opportunities

The nation's children are supremely important assets. Their nurture and care are our responsibility. Children's programme should find a prominent part in our national plans for the development of human resources, so that our children grow up to be robust citizens. They need to be physically fit, mentally alert and morally healthy, endowed with the skills and motivation needed by modern society. The Preamble of the National Policy for Children adopted by the Government of India in August' 1974 sums up the national importance of investment in child welfare for ensuring proper environment and facilities for all children in the country to grow and develop into respected citizens of tomorrow that is still being implemented.

Violence against children is a deep-rooted social problem in India. The problem is related to economic as well as cultural beliefs and practices. There are a number of definitions of violence used depending upon the focus and approach taken towards it. UN Study on Violence against Children (2006) definition of violence draws on Article 19 of the Convention on the Rights of the Child that all forms of physical or mental violence, injury and abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse. Generally, the offences committed against children or the crimes in which children are the victims are considered as violence against children. Indian Penal Code (IPC) and various protective and preventive special and local laws specifically mention the offences wherein children are victims. The age of child varies as per the definition given in the concerned Protection of Children Act, 2000. Therefore an offence committed on a victim under the age of 18 years is construed as violence against children for the purpose of analysis. A total of 89,423 cases of violence against children were reported in the country during 2014 as compared to 58,224 cases during 2013, showing an increase of 53.6%. Madhya Pradesh accounted for 16.9% of total crimes committed against children reported in the country. The next in order was Uttar Pradesh (16.6%), Delhi (10.5%) and Maharashtra (9.1%). The nation develops many preventive laws and care mechanism such as

homes, school for special and needy child etc. But the above situation depicted the urgency in preventive structure to control violence against children. The entire policies, law enforcement and institutional intervention need to be modified and also requires to instrument new plan of action.

Objectives

- To disseminate knowledge and ideas to actualize the situation and prevent violence against children in India.
- To share different models and approaches that has strengthened the protection mechanism.
- To perceive the role of social workers in dealing with this particular issue.
