In terms of the resolution of the agenda 3(iv) of the Academic Council (Siksha-Samiti) of its meeting held on 30.05.2016 duly communicated by the Deputy Registrar (Academic & Research) vide Letter No. Aca/S/19.2/691/2016-2017 dated 28.06.2016, the Supplementary Examination at the Undergraduate Level in Semester-V & VI for 3-years Undergraduate courses and Semester-VII & VIII for 4-years Undergraduate courses only will be conducted by the University for back candidates who have appeared in the Final semester Examination 2016 at Undergraduate Level.

I am directed by the competent authority to notify the following in connection with the Supplementary Examination, 2016.

- 1. There shall be no re-evaluation of answerscripts of the Supplementary Examination.
- 2. The Supplementary Examination will be counted as one of the permissible chances.
- 3. The students of Semester-VI/VIII of Undergraduate courses who have got back in their Semester-V/VII and/or Semester-VI/VIII (as the case may be) will fill up Examination Form and deposit examination fees for the Supplementary Examination from 2<sup>nd</sup> July to 7<sup>th</sup> July, 2016 (without late fees) except holidays and 8<sup>th</sup> & 9<sup>th</sup> July, 2016 (with Late Fees). The students are required to enclose photocopy of the marksheet in which he/she got back in their semester-V/VII and/or Semester-VI/VIII (as the case may be).
- 4. The students who have lost 4<sup>th</sup> chance and have got back in their semester- V/VI and/or Semester-VI/VIII of Undergraduate Courses are eligible to appear in the Supplementary Examination.
- 5. The Supplementary Examination, 2016 of the said course/paper may be held during 14<sup>th</sup> July to 18<sup>th</sup> July, 2016 in both halves (starting from 10 a.m. and 2 p.m. onwards on the same day).
- 6. Separate notification for B.Des. Semester-VII & VIII Supplementary Examination will be issued as the B.Des Semester-VIII Examination is yet to be completed.
