This is for information of all concerned that the competent authority of the University has decided to charge the following fees from the users for using the Swimming Pool:-

a. V.B Students/V.B Staff Wards/
Faculty members Wards
b. Research Scholars

c. V.B Staff/faculty members

d. Spouse of Staff

- Rs. 250.00 per student per month

- Rs. 300.00 per head per month

- Rs. 400.00 per head per month

- Rs. 400.00 per head per month

d. Spouse of Staff
e. Pensioners, their spouse
& max. 2 children
- Rs. 400.00 per head per month
- Rs. 300.00 per head per month

f. Alumni, their spouse
& max. two children
- Rs. 500.00 per head per month

g. Guests of staff and faculty members - Rs. 200.00 per head per slot

Processing Fees and Cost of User Pass: An amount of Rs.200.00 will be charged as Processing Fees and Cost of User Pass. User Pass will be treated as invalid if the user has not deposited swimming pool fees for consecutive six months. The User Pass shall be valid for a year i.e February to November subject to the condition that fees is paid regularly without having a break of six months. Every year, a fresh User Pass will be issued on submitting the fresh application.

The prescribed Application Form is to be downloaded from the University website. Each applicant shall apply in separate Application Form. The filled in Application Form has to be submitted with supported documents as mentioned in the Application Form at the Swimming Pool Counter (except Friday).

Upon approval of the filled in Application Form by the Swimming Pool Committee, the fees will be deposited to the Sports Board Counter located at Swimming Pool from 11:00 a.m to 1:00 p.m on Monday, Tuesday, Thursday and Saturday. On depositing the fees, User Pass will be issued which will be activated with a biometric identification of the individual for whom the card is being issued. Priority will be accorded as under:-

1. Priority 1 - V.B students/Staff Wards studying in different School/College/University

2. Priority 2 - Staff and faculty members

3. Priority 3 - Pensioners, their spouse and 2 children

4. Priority 4 - Alumni, their spouse and 2 children

The fee will be collected from 05 August, 2015. After 14th August, 2015, no one will be allowed to swim without User Pass.
