ABOUT THE SEMINAR

Sustainability is the capacity to carry on. It is about stabilizing the currently disruptive relationship between earth's two most complex systems—human culture and the living world. In ecology the word describes how biological systems remain diverse and productive over time. For humans it is the potential for long-term maintenance of well being, which in turn depends on the maintenance of the natural world and natural resource. As the earth's human population has increased, natural ecosystems have declined and changes in the balance of natural cycles have had a negative impact on both humans and other living systems. The changing climatic conditions have a direct effect on plant growth and vigor, pathogen biology, population dynamics of insects, increase in salinity etc., which contributed negatively in agricultural food production. Awareness on different aspects of ecological environmental factors is of utmost important to cope up against the challenges. Food is understood to be only one of the priorities that people pursue. People are constantly required to balance food procurement against the satisfaction of other basic material and non-material needs. A livelihood is sustainable, when it "can cope with and recover from the stress and shocks, maintain its capability and assets, and provide sustainable livelihood opportunities for the next generation.

Our oldest literature namely; the Veda has ample references which reflect the thinking of Vedic people. The Vedas also contain various aspects of man's relationship with the environment. The basic philosophy seems to be that everything has come out of one singular source and hence each and everything in this universe is related with each and everything else. In the same sequences we also come across in our Indian literature right from the *gveda* upto contemporary age. In Indian writings right from the Vedas, Epics and *Pur a*-s etc. we find many references to ecological thoughts. Many ancient writers in Sanskrit described the importance and significance of *v yu* (gasses and air), *jala* (water), *de a* (topography) and time in the regulation of life, similarly, the concept of *pañcatattva* (five elements) namely; earth, water, air, fire, sky reflect the idea of circulation of materials. Indians have always respected plants and animals. We aim at giving reflections to the notions of world's ancient *i*-s (seers) about the conservation of life and nature and about the fractions of nature as different godheads. Their process of personification and deification of nature has much to say of the ecological values which are relevant in contemporary age.

In the same sequences we also come across the Buddhist texts i.e. Pali literature which speaks much about ecological thoughts of man of the society. Human behavior towards nature and nature's impact on human life is an important factor so far ecological study is concerned. For survival, mankind has to depend on nature for his food, clothing, shelter, medicine, and other requisites. For optimum benefits man has to understand nature so that he can utilize natural resources and live harmoniously with nature. Hence, the present seminar aims at focusing ecological awareness reflected in the Buddhist literature also which may give a great insight to contemporary age so far the theme of the seminar is intended.

Due to the intense publication of data related to the current ecological problem, it is crucial to broaden the debate about the development of actions to minimize environmental destruction by the entire society. Nevertheless, despite the great spread of knowledge about the theme, the expected behavior of environmental preservation is not observed in a significant portion of the population, resulting in difficulties to perform effective actions in this way.

However, the aim of the seminar is to have an academic exercise and discus on the proposed theme from multi-disciplinary fields of study which may give insight to many aspects of human behavior towards their surrounding natural phenomenon. This can also provide an idea to generate a household livelihood security model allows for a broader and more comprehensive understanding of the relationships among the political economy of poverty, malnutrition and the dynamic and complex strategies that the poor use to negotiate survival.
