The Chairperson and Vice-Chancellor, expressed his satisfaction and congratulated Prof Rup Kumar Kar, Chairman, NAAC Committee and his team for a collective effort on preparing for NAAC. He congratulated all the employees and stakeholders for their hard-work. He also appreciated the efforts given by the past chairperson of NAAC committee to initiate the early steps towards preparation for NAAC.

Resolutions:

1. Confirmation of minutes of last meeting

The minutes of the last meeting was read and confirmed with approval from the members of the Committee. The Director, IQAC initiated the discussion by welcoming everyone for the meeting.

2. Preparation of AQAR

Director, IQAC informed the members that the preparation of AQARs for last five years (2015-2020) is complete and endorsement of the same is being sought from the respective Bhavanas. Prof. Kar also informed that the Executive Council at its meeting held on 29.09.2020 has authorized the Vice-Chancellor for approving these AQARs to be uploaded on the NAAC Website.

3. Notification seeking applications for CAS promotion (2020) and related matters

At the outset, Assistant Registrar (Recruitment) stated that until now 126 CAS applications (submitted against the last notification for CAS promotion of the faculties) have been processed and subsequently applicants have been promoted to respective stages and out of rest 65 applications 43 cases of CAS promotion are awaiting selection. Director, IQAC indicated for the necessity of notification for seeking applications from aspiring faculties for promotion to different stages under CAS. In this context, certain points were raised by the Director, IQAC regarding the concerned regulations of UGC for discussion and clarification in the house.

- (i) As per Clause no. 6.3 of UGC Regulations (2018), a candidate may be given the option for applying in the existing (2016) regulations and it can be exercised only within 3 years from the date of these regulations. Can it then be availed till July 2021?
- (ii) Regarding research publications to be considered for individual academic scoring, as mentioned in the UGC regulations (2018) journals must be peer reviewed or UGC listed. Such UGC list first came into effect from 19th July 2017 followed by a curtailed list removing 4305 journals to be effective from 2nd May 2018 and finally the UGC-CARE list became effective from 14th June 2019 onwards. Does it mean that before 19th July 2017, publications in peer reviewed journals only may be considered while afterward the journal must be in the respective list with the corresponding time period?
- (iii) It is not clear from the UGC regulations (2018) whether significant publications (3 or 5) of the candidates applying for promotion to Associate Professor or Professor need to be sent to three External Experts in the relevant subject separately for evaluation before selection.
- (iv) Is there any curb for implementation of promotion to Senior Professor position under CAS?

The above issues were opened for discussion and members have placed their respective opinions. The Hon'ble Vice-Chancellor, Chairperson of IQAC hence decided to seek necessary clarifications from UGC in this regard. A formal letter is to be sent to UGC at the earliest asking for clear and satisfactory answers to the above mentioned questions.

Also, it was unanimously decided that henceforth all CAS applications for all the levels, after screening at Bhavana level, will be routed through the Internal Quality Assurance Cell for further close scrutiny to avoid any kind of irregularity before sending to the Establishment section for further necessary action.
