Admission to Pre-Primary : 1st Year, Mrinalini Ananda Pathshala, Class –II, Class –VII, and for Staff Ward upto Class- IX, Patha-Bhavana, Visva-Bharati

Online applications are invited for admission to Mrinalini Ananda Pathshala: Pre-Primary 1st Year from different categories of candidates, such as, Day Scholar (DS), Alumni-wards (AW) and Staff-wards (SW) for the year 2022.

Who can apply:

- **Open Category/ Day Scholar (DS):** Candidates who do not belong to either Staff-Ward or Alumni Ward category.
- **Alumni Ward (AW):** Wards of the members of the Alumni Association of Visva-Bharati
- **Staff-Ward (SW):** Wards of the permanent staff-members of Visva-Bharati

Neighbourhood Candidates: In case of Open Category and Alumni Wards, 20% of total seats are reserved for Neighbourhood candidates residing within the radius of 1 km of Patha-Bhavana Office, Visva-Bharati, and maintaining Government reservation rules.

(Localities within 1 KM of Patha Bhavana Office: Bhubandanga, Sukantapally, Gurupally South and West, Purbapally, Ratanpally, Simantapally, Lalbandh, Shyambati, Pearsonpally)

Staff-Ward (SW): The wards of permanent staff members who are born between 01.01.2017 to 31.12.2017 can apply to Pre-Primary-1st Year, Mrinalini Ananda Pathshala, provided they fulfill all other criteria.

Mode of Selection: Computerized Random Selection procedure through the computerized lottery system will be followed. Date, time and place will be notified later on the VB admission Portal/University website.

2. Admission of Residential Students to Class II at Patha-Bhavana, Visva- Bharati

Online applications are invited for admission of Residential students to Class II (Boys and Girls) of Patha-Bhavana for the academic year 2022. The medium of instruction is Bengali. Non-Bengali speaking candidates of other states are also encouraged to apply. Alternative medium of instruction is also available in languages such as English, Hindi, etc. for the non-Bengali Speaking Students.

Mode of Selection: Online /offline Test; Date, time and place will be notified later on the University website.

Merit list of Class II:

- Merit list will be prepared solely on the basis of results/marks/score of the Admission test (offline/online)
- If two or more applicants rank the same in the merit list, preference will be given to the candidate senior by birth.

3. Admission of Residential Girl-Students to Class VII at Patha-Bhavana, Visva-Bharati

Online applications are invited for admission of Residential students to Class VII (Girls) of Patha-Bhavana for the academic year 2022. The medium of instruction is Bengali. Applications of candidates from other provinces are encouraged. Once admitted, necessary provisions in this regard can be made accordingly.

Mode Of Selection: *Online /offline Admissiomn Test*; Date, time and place will be notified later on the University website.

Merit list of Class VII:

- a) Will be prepared solely on the basis of results/marks/score of the Admission test (offline/online)
- b) If two or more applicants rank the same in the merit list, preference will be given to the candidate senior by birth.

4. Admission of Staff Wards in Other Classes of Patha-Bhavana, Visva-Bharati

The wards of permanent staff members can apply to a class appropriate to his or her age from Pre-Primary-1st Year, Mrinalini Ananda Pathshala to Class-IX, provided the candidates fulfill all other criteria provided they did not apply on earlier occasions. The staff concerned must be a Permanent employee who is in service at the time of admission of the ward.

5. Admission of Foreign Students to Patha-Bhavana, Visva-Bharati

15% of total number of seats of class is reserved for foreign students on a supernumerary basis. All fresh applicants have to apply under Day Scholar category and need to submit their application through online mode. The application should be routed through Academic & Research Department, Visva-Bharati.

6. Reservation Guidelines for Admission

- i. Reservation in admission to all courses of the University shall strictly be done as per Government of India rules*.
- ii. Percentage of Reservation: 15% seats for SC candidates, 7.5% seats for ST, 27% seats for OBC candidates, 10% seats for EWS candidates and 5% seats for PWD candidates (Horizontal Reservation).

*** Not more than one type of relaxation shall be granted to any candidate.**

Other Backward Class(OBC)

Applicants under OBC category are necessarily required to produce valid NCL certificates to claim the benefit of reservation of seats under OBC category. Link- http://www.ncbc.nic.in/user_panel/centralliststateview.aspx.

Economically Weaker Sections (EWS)

[UGC (MHRD) Order F.No.81-1/2019 (CU) dated 18th January, 2019] CRITERIA OF INCOME & ASSETS:

a. Candidates who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 8.00 lakh (Rupees eight lakh) only are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e., salary, agriculture, business, profession, etc. for the financial year prior to the year of application. Further candidates whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq. ft and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;

- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
- b. The property held by a “Family” in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- c. The term “Family” for the purpose will include the person who seeks benefits of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

Income and Asset certificate issuing Authority and Verification of certificate:

a. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset certificate issued by any one of the following authorities in the prescribed format only be accepted as proof of candidate’s claim as belonging to EWS:

District Magistrate/Additional District Magistrate /Collector/ Deputy Commissioner/ Additional Deputy Commissioner/1st Class Stipendiary Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/ Executive Magistrate/Extra Assistant Commissioner; Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate; Revenue Officer not below the rank of Tehsildar and Sub-Divisional Officer or the area where the candidate and/or his family normally resides.

b. The officers who issue the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the respective state/UT.

c. The crucial date for submitting income and asset certificates by the candidate may be treated as the closing date for receipt of application.

PWD : As per the provisions of the Rights of Persons with Disabilities Act, 2016, not less than 5% seats are reserved for Persons with Benchmark Disabilities (persons with not less than 40% of disability) subject to valid disability certificate issued by the competent authority.

Staff Wards: Wards of Permanent Staff members of Visva-Bharati.

Admission of Permanent Staff wards : The wards of Permanent Staff members can also apply to a class appropriate for his/ her age from Pre-Primary-1st Year, Mrinalini Pathshala to any class in Patha-Bhavana up to Class IX, provided they did not apply on earlier occasions. The staff concerned must be a Permanent employee who is in service at the time of admission of the ward.

[B] Mode of payment: Candidates can make payment online using any of the online payment modes: Net Banking, Debit Card and Credit Card.

No Cash payment will be allowed

[C] Please make payment from the Bank Account of the Parents of the candidate to avoid any problem regarding refund, if any at any stage.

[D] How to Apply:

Candidates must apply through University Online Admission Portal (visvabharatiadmission.samarth.edu.in). No Offline application will be entertained.

[E] Documents to be Uploaded /Produced at the time of Admission:

- a) 'Birth Registration Certificate' issued by competent Government authority. (Form No. 9 or Form No. 5). **To be uploaded.**
- b) Certificate from appropriate Government authorities in case of SC/ST/OBC/EWS candidates. **To be uploaded.**
- c) Valid certificate from government authorities for the differently abled (Divyangjan) candidates. **To be uploaded, if required.**
- d) Progress Report/Mark Sheet of the last examination for previous Class for Class II onwards
- e) Alumni ID card or Letter of Membership from Visva-Bharati for Alumni-Ward. **To be uploaded, if required.**
- f) Visva-Bharati Staff ID Card for Permanent Staff wards. **To be uploaded, if required.**
- g) Medical Certificate from a Registered Medical Practitioner.
- h) Blood Group Certificate.
- i) Copy of online application form.
- j) Three passport Size photographs. **One copy to be uploaded.**
- k) A set of photocopies of relevant documents to be attested by the guardian will have to be submitted at the time of admission.
- l) School Leaving Certificate from the previous School. (to be submitted within fifteen (15) days after getting admission) for class-II onwards.
- m) **Incomplete applications will be rejected. Requests for any sort of addition or alteration in the application form after submission will not be entertained.**

Additional Documents for Neighborhood candidates:

- Photocopy of Family ration card. **To be uploaded, if required.**
- Photocopy of parents' voter card issued by the Election Commission of India. **To be uploaded, if required.**

General Guidelines

- A set of photocopies of relevant documents, duly attested, will have to be submitted at the time of admission, if any.
- School Leaving Certificate (for Class – II onwards) from the school last attended is to be submitted after admission.
- The modalities of Admission Test (wherever applicable) for the Institute will be informed from time to time on Admission Portal.
- Full marks of Admission Test will be fifty (50). The details of the Admission Test will be noticed in due course through University Admission Portal.
- The candidates must bring medical fitness certificate from any hospital or doctor with registration number at the time of admission.
- The Medical Insurance is mandatory. All candidates are required to pay medical insurance fee. Required amount will be informed in due course

- It is mandatory for all admitted students to be present in the class for first fifteen (15) working days from the commencement of class. Otherwise, his/her admission is liable to be cancelled.
- 15% of intake capacity at the University level will be made available for international students/foreign students which will be calculated as supernumerary seats. 5% of seats out of the 15% supernumerary seats for admission of foreign students shall be earmarked for children of Indian workers in the Gulf and South East Asia.
- Applicants are advised to visit VB admission portal: visvabharatiadmission.samarth.edu.in for any updates (inclusion/omission) at regular intervals.
- Candidates/Parents must be very careful during entry of the relevant information during online form fill-up. No claim shall be entertained subsequently for data entry mistakes committed by the applicant at the time of online application.
- **Incomplete applications will be summarily rejected. Request for any sort of addition or alternation in the application form after submission will not be entertained.**
- ***Visva-Bharati Prospectus-2021* (available at: https://visvabharati.ac.in/file/VB_Admission_Prospectus_2021_2022.pdf) shall be followed for any issue or point that is not mentioned in this notification.**
- List of eligible candidates, date, time and venue of Computerized Random Selection procedure for Mrinalini Ananda Pathshala and Patha-Bhavana will be published later on the Admission Portal-visvabharatiadmission.samarth.edu.in
- In case of non-availability of any candidate in a particular category (SC/ST/OBC/EWS/UR) under neighborhood category, that seat will be filled-up by a candidate of the same category under Non-neighborhood category, and vice versa.
- For SC/ST/OBC/EWS certificate, the certificate of the father of the applicant may be uploaded/ submitted, if the same has not yet been obtained from the competent authority in the name of the child.
- **Applicants are advised to visit the VB admission Portal (visvabharatiadmission.samarth.edu.in) for any updates at regular intervals.**
