

NOTIFICATION FOR INVITING APPLICATIONS FOR INTEGRATED M.PHIL.-PH.D. ADMISSION – 2015

In continuation of the Notification issued by the Chairman, VBRET Committee [Ref.No. Aca/VBRET-15/392/2015-16 dated 03-08-2015], this notification is issued as detailed hereunder:

- 1. Applications in prescribed form are invited, for Admission to the Integrated M.Phil.-Ph.D. Course in various subjects in 2015, from the eligible candidates [i.e., Qualified VBRET/NET/SET/GATE, holders of UGC teacher-fellowship, M.Phil-Degree holders (following Minimums Standards and Prodecure for awards of M.Phil./Ph.D. Degree, Regulation, 2009) and other VBRET exempted categories as per extant M.Phil.-Ph.D. Ordinance of Visva-Bharati]. The candidates must have obtained a Master's Degree with a minimum of 55% marks or B+ grade in the concerned or an allied subject preceded by a Bachelor's Degree or an equivalent degree from a recognised University/Institute. Due relaxation shall be given to the applicants belonging to the reserved categories as per the rules of the Govt. Of India. For International Candidates, separate prescribed application form may be obtained from the office of the Joint Registrar (Academic & Research Department), Visva-Bharati and University website. International candidates shall be exempted from VBRET or other entrance test but they must fulfil the required academic criteria laid down in the concerned departments.
- 2. Prescribed application forms may be obtained from Sangit-Bhavana Office on production of a Cash Coupon (₹ 500/- for General/OBC candidates and ₹ 150/- for SC/ST/PWD candidates) issued from the Accounts Office, Visva-Bharati. Prescribed application fee as noted above, may also be deposited in the form of a Demand Draft issued in favour of "ACCOUNTS OFFICER, VISVA-BHARATI" drawn on State Bank of India, Santiniketan (Code: 2121), payable at Santiniketan while obtaining the Admission Form.

- 4. The candidates should attach the self-attested photocopies of the following items along with the application forms:
- (a) (i) Marksheets & Certificates of all previous public examinations [e.g., Secondary, Higher Secondary (10+2), Bachelor's Degree, Master Degree, M.Phil., etc.].
 - (ii) Birth Certificate.
 - (iii) Caste Certificate (SC/ST/OBC), if applicable.
 - (iv) Disability/PH Certificate, if applicable.
 - (v) Current family Income Certificate, if applicable.
- (b) Recent passport size colour photograph of the candidate.
- 5. The eligible candidates (who have qualified the VBRET and the practical test) will have to appear for an interview before the Board of Studies of the concerned department as per the schedule stated above (para 3.C). Such candidates must bring all original documents, marksheets, certificate, etc.

- 6. The time schedule as stated in para 3 above, may vary. The university website may be visited for any update.
- 7. (a) Selected candidates will have to pay admission fee (approximately ₹ 15,000/-) to the Accounts Office, Visva-Bharati during admission and they should also bring the following items during admission:
 - (i) All documents [as referred to in para 4(a) above] in original.
 - (ii) Two copies of recent colour photo (passport size) of the candidate.
 - (iii) Medical Certificate from any Registered Medical Practitioner (Doctor).

(b) Legal guardians must accompany the candidate during admission (exemption for international applicants)
