Celebration of Tagore's Birth-Anniversary
1 June 2016, Kolkata

The celebration of Rabindranath Tagore's Birth Anniversary was held at Kalamandir on 1 June 2016. In his welcome speech Dr Ramkumar Mukhopadhyay, Director, Visva-Bharati Granthana Vibhaga, discussed how the modern Bengali book publication got its direction with the establishment of the Granthana Vibhaga in 1923. He added that the Granthana Vibhaga with an annual production of nearly 80 titles and an annual sale of more than two and a half crores, is the most successful university publication in the country.

Prof Swapan Datta, Hon'ble Vice-Chancellor, Visva-Bharati in his speech dwelt on the relevance of Tagore's ideas and ideals in the 21st century. He explained how Tagore's ideas of agriculture, environment and education are appearing to be more and more relevant and necessary with the passage of time. He added that Tagore ignored the narrow nationalism to reach out to a bigger world involving all the nations with their diverse socio-cultural identities.

Many eminent Rabindrasangit singers including the Sangit Bhavana faculties sang songs in the programme. The songs were followed by the performance of the dance drama *Chandalika* by the students of the Visva-Bharati.
