The President of India is the Paridarsaka (Visitor) of the University, the Governor ofWest Bengal is the Pradhana (Rector), and the Prime Minister of India acts as the Acharya (Chancellor). Bolpur-Santiniketan is connected both by railway line and road. It takes around 3 hours either by road/train to reach Bolpur-Santiniketan. The nearest railway station is Bolpur-Santiniketan on the Eastern Railway and the air terminals are Kazi Nazrul Islam Airport, Durgapur and Netaji Subhas Chandra Bose International Airport, Kolkata.
