Social cohesion as a characteristic of society demonstrates the interdependence between individuals in the society. A cohesive society is a mutually supportive community of responsible individuals pursuing their common goals with democratic values and practices.

Collective responsibility is connoted as shared responsibility or the responsibility of the collective entity. It requires, not only the collective actions and intentions, but a collective mind to deal with any crisis. It is also understood as an intellectual construct that enables the coherence of collective actions and group intentions in the communities.

As we discussed, the communities across the globe, today, need collective action to handle not only the current crisis of Covid-19 but also all other unrelenting socio-political, economic and environmental issues beset the humanity. Thus, social workers have a central role in promoting social cohesion through collective action that involves collective responsibility for betterment of all with human values and rights.

About the Congress

The Indian Social Work Congress is an initiative of National Association of Professional Social Workers in India (NAPSWI). The purpose of this Congress is to bring fraternity of professional social workers together to discuss and deliberate upon the issues related to social work profession in general, social work education, research and practice in India as well as in other contexts. The Indian Social Work Congress aims to strengthen social work profession to ensure social justice and human rights for all. The Congress also aims to register the responses of social work profession to the changing situations and response of the profession. ISWC aims to act as a forum for *understanding the importance of collective responsibity and social cohesion for sustainable social development and revisiting the role of social work profession* between social work fraternity and other stakeholders such as people in general, civil society sectors, funding organisations, government, etc.

Specific Objectives

- 1. To provide a platform to social work professionals to discuss and deliberate on the issues related to social cohesion, social responsibility and social work during the changing scenario and delve into the innovative research and practice.
- 2. To deliberate upon roles and responsibilities of social work professionals in changing socio-political context with respect to social responsibility.
- **3.** To share and exchange realities amongst social work educators, researchers and practitioners to discuss and debate the issues related to social work profession in India and across the globe and reflect upon contemporary issues related to social work profession and its response.

Sub-themes

The sub-themes are proposed as frameworks for the detailed deliberations under the theme. What is generally expected are the conceptual, empirical and interventional papers or posters in terms of the causes, consequences, current status, strategic interventions, potential responses in management lines including policies and programmes with social work implications to the education, and practice.

- 1. Social work education and profession: Related Issues including formation of SW Council
- 2. Social work, community resiliance and social cohesion during COVID-19 and new normal
- 3. Social work, SDGs and issues towards social, economical and environmental sustainability
- 4. Families, women, children, youth and others during COVID-19 pandemic
- 5. CSR, social enterpreneureship, working class, occupational social work and World of work
- 6. Health, public health, mental health and social work in pandemic times
- 7. Social work with vulnerable groups, dalits, tribals, minorities, disabled, LGBTQ and others
- 8. Civil society, social service workforce and empowering people and their rights
- 9. Social policies especially related to people's development, National education policy,
- 10. Digital divide, new challenges and digital social work

Call for Papers

Papers are invited from the participants on any of the above sub-themes proposed. We invite the academia as well as professional social workers in particular and others interested to submit the abstract **on line** through our website. The abstract should not exceed 500 words and it should include the author's name, designation, affiliating institution, mailing address, contact number, E-mail ID, title of the abstract and text. **We are open to accepting the abstract till 31**st **January 2021**. Once the abstract is received, it will be reviewed and the acceptance will be communicated within seven days. Accepted abstracts of the registered delegates will be published in the book of abstracts.

We propose to have online **oral as well as poster presentation.** Only selected papers will be accepted for presentation and should be accompanied by MS Power Point format and full paper in detail. The length of full paper including tables, diagrammes, illustrations, references, etc. should not be more than 5000 to 6000 words. The full paper should be in English and typed in MS-Word in Times New Roman with font size 12. Bibliographical references should be arranged alphabetically and given at the end of the text in the APA format only. The full version of paper should be submitted in **soft copy** latest by 20th February 2021. The selected papers will be published in an edited book.
