#### **NOTICE INVITING APPLICATIONS FOR QUARTERS**

This is to inform all concerned, that the following University quarters are available for allotment. Permanent employees who enjoy the rank and scale of pay may apply against the qtrs.

An employee, who is already in occupation of quarters, may apply for change of quarters, if no change in the same type has been made earlier. However, <u>no change is allowed within a year of</u> allotment.

Applications through proper channel should reach the office of the undersigned within 28/02/2025.

#### Tentative date of Meeting of Allotment (Sub-Committee):- 1st week of March, 2025

- A. Allotments will be made to the employees other than new MTS employees, on the basis of seniority in service as detailed below.
- B. Allotments will be made to the new MTS employees, on the basis of inter-se seniority (rank/merit wise).
- C. Seniority for academic quarters will be calculated on the basis of date of joining academic posts only.
- D. Seniority (other than new MTS) for a particular type of qtrs. will be calculated on the basis of <u>date of joining in an eligible post</u> only.
- E. Separate applications are to be made for different types of quarters.
- F. Allotment will be made on, as is where basis is.
- G. Applicants may visit the quarters they wish to apply for & satisfy them selves before submitting their applications.
