Tender papers will be sold to the intending bidders on certification from the University Engineer, Visva-Bharati at Santiniketan against the application to be submitted by the contractor for purchase of tender paper in the prescribed form available from the office of the University Engineer.

Intending bidders are eligible for application provided he has the definite proof of satisfactory completion of at least one similar works of value **not less than 40%** of the estimated cost in last 5 years ending previous day of last date of submission of bids.

For electrical work, the bidder should have valid electrical license with full time engagement of electrical supervisor holding supervisor certificates of S.C.C. Part 1, 2, 6A, 7A & 11 issued by the Licensing Board, Govt. of West Bengal / other States or equivalent National Supervisor Certificates of competency.

Bidders must submit the copies of valid **GST registration, credential of satisfactory completion of work, Electrical licenses** as specified, along with the application. The originals of those are to be shown as required.

The applicant who fulfills the stipulated conditions may obtain tender form, from the **office of the University Engineer, Visva-Bharati, Santiniketan** on all working days (**except Saturday, Sunday & Other holidays**) on payment of the sum as shown against the work in the cash section.

**Cash section remains open from 10:00 am to 1:30 pm on all working days except Saturday, Sunday & other holidays.**


