## TERMS AND CONDITIONS

- 1) The engagement is purely on contract basis initially for a period of six months with effect from the date of joining, or till a regular candidate joins, whichever is earlier. Contract service may be extended from time to time provided authority is satisfied with the service of the candidate and the posts are not filled up by permanent candidates. Contract engagement may be terminated at any time on either side by giving at least 15 days notice. Visva-Bharati reserves the right to terminate the contract engagement by paying remuneration for half a month in lieu of notice without assigning any reason.
- 2) The contract employee shall perform the duties assigned to him/her in regards to their Designated Post. In addition, he/she may be engaged in some other duties by the competent authority for which no extra remuneration will be paid.
- 3) The contract employee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance treatment, Seniority, Promotion etc. or any other benefits available to the Government servants appointed on regular basis.
- 4) The contract employee will not have any claim or right for regular engagement to any post in Visva-Bharati.
- 5) No Dearness Allowance or any other allowances like HRA, TA or other benefits like LTC, Leave Encashment etc. shall be admissible to the contract employee.
- 6) The contract employee shall be on the whole time engagement.
