- 1.1 This estimate mentioned above, however, is given merely as a rough guide. The estimated cost is exclusive of GST and Labour Welfare Cess which will be paid additional as applicabl

- 1.2 Criteria of eligibility for submission of bid documents :

Intending bidders are eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed works specified below. These should be certified by officers not below the rank of Executive Engineer or equivalent.

For electrical work:

- (i) One electrical construction / repair works each of value not less than **Rs.6,22,532.00** or 2 nos. of work each not less than **Rs 4,66,899.00** or 3 nos of work each not less than **Rs 3,89,082.00** in last 5 years ending previous day of last date of submission of bids.
- (ii) For electrical work the bidder should have valid electrical credential as stated under clause 1.2 above and valid electrical license with full time engagement of electrical supervisor holding supervisor certificates of S.C.C. part-1, 2, 6A, 7A & 11 issued by the Licensing Board, Government of West Bengal / other States of equivalent National Supervisor Certificate of competency

2. Agreement shall be drawn with the successful bidders on prescribed Agreement Form. Bidders shall quote his rates as per various terms and conditions specified in the general directions and conditions of contract which will form part of the agreement.
3. The time allowed for carrying out the work will be as specified above from the date of start as defined in work order or from the first date of handing over of the site, whichever is later.
4. The site for the work is available.
