सर्व संबंधित को सूचित किया जाता है कि यूजीसी, नई दिल्ली के दिनांक 25/11/2024 के पत्रांक एफ नं. 67-3/2021 (सी यू)/104258 (प्रति संलग्न) के माध्यम से किए गए पत्राचार के अनुसार, जिसके साथ कार्मिक, लोक शिकायत एवं पेंशन मंत्रालय, भारत सरकार द्वारा जारी दिनांक 18/09/2024 के कार्यालय ज्ञापन संख्या 1/5/2024 - पी एंड पी डब्ल्यू (एफ) - 9809 (प्रतिलिपि संलग्न) की एक प्रति अग्रेषित की गई है, सी सी एस (असाधारण पेंशन) नियम 1939 के तहत निरंतर परिचर भत्ता (सी ए ए) को मौजूदा रू0 6750 से 25% बढ़ाकर रू0 8438 प्रति माह कर दिया गया है। सी सी एस (असाधारण पेंशन) नियम 1939 के अंतर्गत 100% विकलांगता (जहाँ व्यक्ति दैनंदिन कार्य के लिए पूरी तरह दूसरों पर निर्भर है) के लिए विकलांगता पेंशन पर सेवानिवृत्त होने वाले पेंशनभोगियों के संबंध में 01/01/2024 से मँहगाई भत्ते में 50% की वृद्धि की गई है। यह कार्मिक, लोक शिकायत एवं पेंशन मंत्रालय, भारत सरकार, नई दिल्ली के दिनांक 16.04.2009 के कार्यालय ज्ञापन ओ एम नं. 45/6/2008 - पी एंड पी डब्ल्यू (एफ) (प्रतिलिपि संलग्न) में निर्धारित नियमों और शर्तों के अनुपालन और पूर्ति के अधीन है।

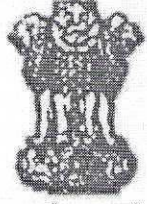

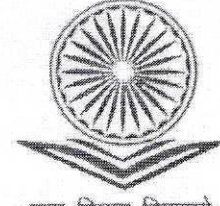

विषय : Enhancement of Constant Attendant Allowance (CAA) under CCS (Extraordinary Pension) Rules, 1939 / 2023 - reg.

The undersigned is directed to refer to this Department's O.M. No.1/4/2017-P&PW(F) dated 3rd October, 2017 conveying that the rate of Constant Attendant Allowance payable to the Civilian pensioners shall be increased by 25% every time the dearness allowance on the revised Pay in the Pay Matrix increased by 50% (copy attached).

2. Department of Expenditure vide their OM No. 1/1/2024-E-II(B) dated 12.03.2024 has issued instructions regarding enhancement of Dearness Allowance Rates from existing 46% to 50% of the Basic Pay with effect from 1st January 2024. Accordingly, all the Ministries / Departments may enhance the amount of Constant Attendant Allowance by 25% from the existing Rs.6750/- to Rs.8438/- per month with effect from 01.01.2024.

3. This issues with the approval of competent authority.

OFFICE MEMORANDUM

Subject: Implementation of Government's decision on the recommendation of the Vth CPC - revision of CCS (Extraordinary Pension) Rules, 1939 - Constant Attendant Allowance.

The undersigned is directed to say that on the Recommendations of Sixth Central Pay Commission in para 5.1.44 of its Report, orders were issued vide Department of Pension & Pensioner's Welfare O.M. No.38/37/2008-P&PW (A) dated 2.9.2008 that:

"In the case of pensioners who retired on disability pension under the CCS (Extraordinary Pension) Rules, 1939, for 100% disability (where the individual is completely dependent on somebody else for day to day function), a Constant Attendant Allowance of Rs.3,000/- p.m. shall be allowed in addition to the disability pension, on the lines existing in Defence Forces."

2. Accordingly, the payment of the Constant Attendant Allowance (C.A.A.) shall be governed by the provisions as under:-

- (i) Constant Attendant Allowance (C.A.A) will be Applicable to cases where the disability for which Constant Attendance Allowance is payable is attributable to or aggravated by service.
- (ii) Constant Attendant Allowance (C.A.A) may be granted to a Government servant who is awarded a disability pension for 100 percent disablement, if in the opinion of the medical board, he needs the services of a constant attendant for at least a period of three months, and the necessity arises solely from the condition of the accepted disability or disabilities.
- (iii) Constant Attendant Allowance (C.A.A) shall not be payable for any period during which the pensioner is an inmate or an in-patient of a Government institution or hospital.
- (iv) Payment of Constant Attendant Allowance (C.A.A) shall be made along with disability pension. Payment shall be made on the basis of declaration as in Annexure which shall be submitted to the Pension Disbursing Authority in May & November each year.

3. Formal amendments to the Central Civil Services (Extraordinary Pension) Rules, 1939, are being issued separately.

4. These orders are issued with the approval of the Ministry of Finance, Department of Expenditure vide their U.O.No.7.32/10/2009-IC dated 23rd February, 2009.

5. In their applicability to the personnel of the Indian Audit and Accounts Department, these orders issue in consultation with the Comptroller & Auditor General of India.

6. Ministry of Agriculture, etc. are requested to bring the contents of these orders to the notice of the Heads of Departments, their Attached and Subordinate Offices, Controller of Accounts, Pay & Accounts Officers, etc. under their administrative control,
