3. The sealed quotations must reach / drop in the tender box kept at P M Hospital, Office, Visva-Bharati, Santiniketan on or before 21-12-2023 within 5 pm.
4. Both the above envelops should be put in the third envelop & super scribed "QUOTATION FOR MEDICINE PURCHASE FOR 2023-2024." Also COMPANY'S NAME/ AGENCY'S NAME be mention in details on the envelop.
5. VALIDITY OF OFFER: The quotation should have validity for one year only from the date of quotation.
6. Medicines and pathological items to be supplied with 80% shelf life.
7. The agent or company should have local Supplier/Distributors / Stockiest Center at Bolpur


