\*\*\* As per rule, they are not eligible for the quarters, but allotment has been made to them by relaxing the eligibility criteria to prevent damage of the quarters since the quarters are lying vacant for a long time and there are no eligible applicants for these quarters.

### These quarters are reserved for ST, but they have been lying vacant for long time and they are not eligible ST applicants for the quarters. To prevent damage these quarters have been allotted to these employees.

## Relevant portion of the Rules:-

- 1. If an employee fails to accept the allotment of residence made to him under the rules, within **Sevendays** or fails to take possession of the residence after acceptance, **within 30 days** from the date of receipt of the letter of allotment, he/she shall not be eligible for another allotment for a period of one year from the date of issue of allotment letter and the residence shall be allotted to the next eligible employee.
- 2. Where an employee who is in occupation of a residence is allotted another residence and he/she occupies that residence, the allotment of the former residence shall be deemed to be cancelled from the date of occupation of the new residence. He may, however retain the former residence without payment of licence-fee for the day and the subsequent day of shifting.
- 3. Provided that if the former residence is not vacated by the subsequent day as aforesaid, the employee shall be liable to pay damage for use and occupation of the residence equal to the market licence-fee to be determined by the Accommodation Committee from time to time or double the penal licence-fee under FR-45-B with effect from the date he/she takes possession of the latter residence.
