In partial modification of the examination notifications vide Memo No. Exam.E.8.9/2024-25 dated 15-04-2024 & 18-04-2024, the undersigned is directed to convey the following decisions taken unanimously in the meeting with the Principals of all Bhavanas/Vibhaga & Officials held on 19.04.2024 and approved by the Competent Authority :

1. The Broad Examination Schedule for the Terminal semester and Intermediate semesters (except semester-II) be extended upto 7<sup>th</sup> June, 2024 (i.e. 10<sup>th</sup> May to 7<sup>th</sup> June, 2024).
2. The Departments/Centres will have the option to hold the Intermediate Semester Examinations, as per their convenience, before the Summer Vacation or after reopening. Those Departments/Centres opting to begin Intermediate Semester Examinations before Summer Vacation, but unable to complete all of them by the 7<sup>th</sup> of June, 2024, can hold the rest of the examinations between 8<sup>th</sup> & 25<sup>th</sup> of July, 2024. The Departments/Centres opting to hold the Intermediate Semesters examinations entirely after the Summer Vacation may do so between 8<sup>th</sup> & 25<sup>th</sup> of July, 2024.
3. The examinations for GEC-4(Theory) will be held on 8<sup>th</sup> July, 2024 and GEC-4 (Practical) will be held on 9<sup>th</sup> July, 2024.
4. The Summer Vacation will be scheduled from 04-06-2024 to 04-07-2024 as notified earlier. The Bhavanas/Departments/Centres which will be holding the examinations till 7<sup>th</sup> June, 2024, may send the names of the teacher(s) detained on examination duty, to the Administration/Registrar seeking Compensatory Leave(s).
5. If necessary, the examinations may be conducted on weekly off-days.
6. Keeping in view the General Elections to the Lok Sabha 2024, the Bhavanas/Departments/Centres will prepare the revised examination schedule excluding P-1/2, P(polling day) & P +1/2 as decided by the Bhavanas/Departments/ Centres to allow the students, teaching and non-teaching employees to enable them to cast their votes.
