**16. Multidisciplinary / interdisciplinary**

The multidisciplinary of Visva-Bharati is embedded in its very mission- " to study the mind of man in its realisation of different aspects of truth from diverse points of view." To this end, the diversity of the faculties and streams in Visva-Bharati comprises Music (Sangit-Bhavana), Arts (Kala-Bhavana), Languages (BhashaBhavana), Humanities and Social Sciences (Vidya- Bhavana), Natural Science (Siksha-Bhavana), Education (Vinaya-Bhavana), Agriculture (PalliSiksha-Bhavana) and Rural Development & Social Work (Palli SamgathanaVibhaga). In addition, the vision of holistic education is embodied in its exclusive festivals like Vrikshatropan (Tree planting), Halakarshan (tilling land), Poush Utsav and Basanta Utsav (interaction with communities during observance of seasons) Stemming from unique school system of Patha-Bhavana and Siksha-Satra where the students are taught about arts, music, nature, society and extension activities at the same time interdisciplinary of Visva-Bharati germinates through off-beat departments like Integrated Science Education, Studies in European Languages and Cultures, Indo-Tibetan Study, Rural Development, Rural Management etc. VisvaBharati had implemented the Choice based credit system (CBCS) from 2017-18 where students choose their General Education Course (GEC) subjects from across all the different streams indicated before. In addition they would required to take courses in languages, Environment studies and Tagore Studies where they are inculcated in the philosophy and values of our founder, Gurudev Rabindranath Tagore. Very recently, from the academic session 2023-24 Visva-Bharati is taking this all-inclusive approach another step forward by

initiating the Four Year Undergraduate Programme (FYUP) as recommended by NEP 2020. The undergraduate students now have to take 2 Minor Fields of 16 credits in addition to a Major Field with 84 Credits. In addition they have to take 3 Multidisciplinary courses of 3 Credits each. They have to take 2 Modern Indian Language Courses and 2 English Courses each of 2 Credits and 2 Common Value Added courses like Tagore Studies and Environmental Studies of 3 credits each. Further the student has the opportunity of multiple entry and exits at the end of 1st, 2nd and 3rd years.

#### **17.Academic bank of credits (ABC):**

To facilitate the mobility of the students across institutions as well as disciplines and choose their own learning path through multiple entry and exit by digitally storing credits, Visva-Bharati has registered in the Academic Bank of Credits (ABC) platform. All bona fide and regular students are advised to open academic bank account on ABC- Digilocker portal and mention it at the time of online registration and examination forms at [vbu.uacanapply.com/visva-bharati.samarth.edu.in](http://vbu.uacanapply.com/visva-bharati.samarth.edu.in) and the same procedure of mentioning their Digi-Locker and ABC number to be followed while filling the online examination form for the students who are pursuing the courses of Visva-Bharati. Visva-Bharati students' community showed enormous enthusiasm in this registration spree. Until now 4789 students have already created their ABC -IDs and 9155 certificates of degrees have already been uploaded on the Digilicker portal.

#### **18.Skill development:**

Visva Bharati encompasses a large number of programmes and courses oriented towards strengthening vocational education including degrees and diplomas in Agricultural Sciences, Education (B.Ed and M.Ed) , Rural Management, Social Work, Computer and System Science, Biotechnology, Journalism and Mass Communication, Textile, Glass Design and many others. All these programmes are intertwined with the mainstream education curriculum as students outside these Departments can also access to take these courses as Minor/General Education / Multidisciplinary courses. Additionally, students of every department under the CBCS system are also required to choose a Skill Enhancement Courses. Silpa-Sadana, an ethnic Department under Palli SamgathanaVibhaga at Sriniketan, is unique in developing and revitalizing cottage industries and craft. It was set up in the name of "Vichitra Studio" at Santiniketan in 1922. Later it was shifted to Sriniketan in 1928 in the name of "Industries Department of Sriniketan" as an integral part of Tagore's Sriniketan experiment on Rural Re-construction. Finally, In 1938, it was renamed as Silpa-Bhavana and it was made a department under PalliSamgathanaVibhaga in

the name of Silpa-Sadana after Visva-Bharati became the Central University in 1951. It is well known for its technical training and production activities in various craft-based trades for the benefit of the rural sector since its inception. The Bachelor, Masters and Certificate courses in skill-based course like wood works, textiles and ceramics have gained popularity among huge number of students, both in state and outside state. Moreover, to invigorate the value-based positivity towards life, the students have to study Tagore Studies which incorporates the humanistic, ethical and human values embodied in the motto of Visva Bharati ' jathavisvambhabatyekamnidam". The syllabus of Tagore Study is sketched on the concept of Rabindranath Tagore's thought exuding truth, ethical conduct, peace and love, as emancipated in Upanishada and Veda. The existing credit structure under the CBCS syllabus being implemented since 2017-18 mandates that students in the Undergraduate Programme have to take 2 Skill Enhancing Compulsory Courses (SECC) of 2 credits each. The new New Education Policy , implemented for Four Year Undergraduate Programme (FYUP) has been initiated from the academic session 2023-24. It requires students to take 3 SECC courses of 3 credits each as well as 1 summer internship of 4 credits.

#### **19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

Visva Bharati, is distinctive in that the Kala Bhavana (Fine Arts), Sangeet Bhavana (Music-including Hindusthani Classical and Rabindrasangeet), and Bhasha Bhavana (Languages - including Sanskrit, Pali and Prakrit, Santhali, Bengali, Hindi, Odiya, Assamese, Tamil, Marathi etc) are largely focused on Indian Art, Culture and language Studies. Additionally, the Departments of Philosophy and Comparative Religion, Ancient Indian History, Culture and Archaeology also are available to students, offered as both Major and Minor fields. The Faculty of Languages (Bhasha Bhavana) is a miners' trove which endows learning of not only the Indian classical languages but also Indian tribal language. Technically speaking, Bhasha Bhavana offers degree and Masters courses in Bengali, Hindi, Sanskrit and Pali,, Odiya, Santhali, as well as Minor and Diploma programmes in Tamil, Marathi. Specifically, Dept of Odiya boasts of a well documented museum hovering authentic items of ancient Odiya civilization. Apart from that Kala Bhavana bestows the curriculum on painting, sculptor where traditional Indian techniques of art form are given a priority of learning.

#### **20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

Visva Bharati offers multifareted outcome based programmes and

courses mainly oriented towards consolidating vocational education along with main stream educational curriculum. Few exceptional courses imparting degrees and diplomas in Agricultural Sciences, Education (B.Ed and M.Ed), Rural Management, Social Work, Computer Science, Biotechnology, Journalism and Mass Communication, Textile, Glass and Ceramics etc. would surely garner appreciation from the perspective of outcome based education. All these programmes are integrated into the mainstream curriculum as students outside these departments are also required to take these courses as Minor/ General Education/ Multidisciplinary courses. For example, Silpa Sadana, a department under Palli Samgathana Vibhaga at Sriniketan is a pioneering institute in India with outcome based education centering around Indian traditional and rural resources. It is engaged in developing and revitalizing cottage industries and craft to empower rural sector. It is well known for UG and PG programme based on technical training and production activities in various craft-based trades for the benefit of the rural sector since its inception.

#### 1.1 - Curriculum Design and Development

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which is reflected in Programme outcomes (POs), Programme Specific Outcomes(PSOs) and Course Outcomes(COs) of the Programmes offered by the University

1. Visva-Bharati has been following the undergraduate Choice Based Credit System since the odd semester of 2017.
2. It has implemented NEP 2020 for UG from the 2022-2023 session.
3. Visva-Bharati already had a holistic approach to pedagogy and knowledge-dissemination in a milieu of peaceful tranquillity where nature, ecological sustainability and local community-connectivity were in place and institutionally internalised since the 1920s.
4. Individual departments/centres as well as various discipline-

clusters, schools, institutes dealt with the formulation and implementation of various Programme Specific Outcomes (PSO), Programme Outcomes (PO) and Course Outcomes (CO) in their own unique and enabling ways based upon guidelines from the centre.

5. Some of Visva-Bharati's priceless contribution to world knowledge and culture may be seen in Kala Bhavana and Sangit Bhavana. These two traditional sites of Visva-Bharati trace their genesis and continuity directly from the inspiration and works of Rabindranath Tagore. Thus, these two academic and cultural spaces are both maintaining an unbroken chain of tradition and culture that is uniquely global as well as regional and national as Tagore had already brought and incorporated a confluence of world culture through his incorporation of Eastern and Western influences and practices. The Palli Samgathana Vibhaga and Palli Siksha Bhavana are very popular educational destinations not for the institute but for also abroad.

1. The tenets, theories, histories, schools and philosophies related to gender and women's studies, ecology and environment are part of taught courses as reflected in primary texts as well as in secondary linguistic/literary/ historical/cultural texts and discourses especially in the institutes/departments of literatures, social sciences, rural reconstruction, education and the like.
2. There is a dedicated Centre for Women's Studies, besides, the Department of Environmental Science at Visva-Bharati offering equivalent compulsory course taught at the undergraduate level.
3. Departments of social reconstruction, rural studies and the like also teach practical and theoretical courses related to disability studies and women's empowerment which are areas that are also taken up by the agriculture studies department that have a hands-on approach towards gender, environment, sustainable farming and ecological processes in the actual practical agricultural domain in the villages and small towns in and around Santiniketan-Sriniketan.

4. Festivals like Briksharopana or the tree plantation festival highlights the intimate relationship between the human and the natural and has been accepted as a standard practice in pedagogy and awareness across the country and beyond.

**2.2 - Catering to Student Diversity**

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

1. Visva-Bharati rigorously implements all approved modes of continuous assessment all through the entirety of the semester periods including internal assessments that is reflected in the end-semester results to the tune of 20% of the total marks per course. To bring parity and to give students a chance to improve, these assessments are spread throughout the semester period with at least two internal assessments per course over and above the all-round comprehensive academic nurturing that all students and scholars receive from the institution.

2. These above-mentioned internal assessments are initiated through various modes of evaluation like written examinations, assignments, paper-presentation, viva-voce, and the like which are then followed up for corrective measures by individual teachers and departments.

3. Evaluation here also remedial coaching and programmes have been in vogue for many years as well as a solid layer of tutorials and academic mentoring systems that have been successful at many levels. Periodic revisions at the department levels with reference to individuals, programmes, courses, and academic batches at micro- and macro levels of intervention and hand-holding are frequently initiated.

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

1. Scholars/senior scholars of all departments across the

university are actively engaged in the teaching learning processes where they effectively, and with great success, help in assisting the teachers/instructors in their daily coursework of academic and peripheral activities and in this process help in upgrading their own skills and pedagogical approaches in their respective fields of academic interest and studies. Departments under the institutes of agriculture and rural development have socio-economic rural connectivity that all students are required to take as part of their coursework among localised farming communities for whom they often serve as secondary – and in many cases, primary – founts of knowledge, skills and professional guidance.

2. Inter- and multi-disciplinary courses, conferences, seminars, workshops, lecture-demonstrations, as well as academic interaction with professional writers, artists, musicians, sportspersons, archivists, scientists, bureaucrats, and the like are integral to the average semester pedagogical practices at Visva-Bharati
3. Visva-Bharati has an extremely rich and unique cultural heritage with a global presence that is anchored in the myriad festivities and utsavs that dot the cultural calendar and which are an integral part and parcel of the university's academic and pedagogical practices as envisioned by Gurudev.

1. All Institutes, as well as most departments and academic spaces, at Visva-Bharati have various audio-visual tools and teaching aids like LCD projectors, audio lecterns, smart boards, and the like, so that students benefit from access to digital resources and can shape their learning processes at par with global standards of teaching-learning initiatives.
2. Smart boards and smart classrooms across Visva-Bharati are increasing as departments and institutes are putting emphasis on these teaching tools as indispensable to modern pedagogy. Digitisation of resources and making them available in the correct format through distant mode using online processes so that teachers, students, and scholars alike can access them in real time, as well as assimilation of internationally renowned e-resources like INFLIBNET and so on, is changing the nature of teaching and learning processes at Visva-Bharati.



3. Introduction of digitisation and internet-based modes of internal assessments and assignments, MPhil and PhD pre-submissions, presentations, examinations, viva-voce, and so on, have become very common practices across the university and institutes/departments.

Since 2016 Visva-Bharati has been following (and has since internalised and perfected the process) the online automation system related to the examination process which was developed by a third party. Under this system all students and scholars have their own account under this module where they can activate their registration process for each individual semester including the optional courses, pay the examination fees, access their online admit cards to the examinations and partially view their results. Results are published manually and processes to initiate an online documentation of results simultaneously are in place.

All admission procedure to all programmes at Visva-Bharati are controlled and initiated through SAMARTH. Examinations and pre-examinations are also conducted through SAMARTH.

Appointments of all examination related personnel - like examiners, paper-setters, moderators, invigilators - are completed online. Evaluation and re-evaluation are simultaneously completed manually and online to eliminate disparity. Publication of semester and other results, preparation of marksheets, provisional certificates, reports, transcripts, migration certificates and so on are executed through this automated online examination management system. Students have access to their accounts within this system where they are required to fill in their examination forms and they have access to their admit cards and results.

1. Visva-Bharati has eight institutes of higher education and two schools under its academic system. The university has two sprawling connected campuses at Santiniketan and Sriniketan which are scattered and amidst the nature. Visva-Bharati has a unique blend of traditional and smart classrooms and teaching-learning spaces ranging from state of the art laboratories, language laboratories and audio-visual galleries.

2. All institutes have their separate sets of buildings. 5. The core Ashrama area is flanked on one side by the massive KhelaarMaath - playing field - that has been the centre of various activities for over a century. 6. Visva-Bharati has a stadium with galleries with a large playing area that hosts football, cricket and track-and-field events near the international standard swimming pool adjacent to the physical education departments.

Visva-Bharati has an extraordinarily competent and fully-equipped Engineering Section that looks after all maintenance and repair work, including structural, electrical, waterworks and sewage. Plumbers, engineers, supervisors, electricians and carpenters are always on call. Sanitation and garden departments look after the daily upkeep of the common areas and gardens. The PRO looks after transport facilities, and annual maintenance is done on all vehicles, including ambulances for the hospital. Cleanliness and hygiene of classrooms, seminar halls, toilets/washrooms and shared areas are maintained by women's self-help groups and university employed/outsourced cleanliness and sanitation staff. Laboratories, libraries, hostels, guest houses, gymnasiums, playgrounds, swimming pool, studios and workshops, hospital and emergency facilities, etc. are all looked after by appropriate and competent university authorities who follow standard protocols of maintenance of equipment and facilities as per government rules and equipment usage and instructions. Tagore's ideals of rural empowerment through socially holistic and cartographically inclusive endeavours led Visva-Bharati to invest in rural reconstruction and agricultural sciences supported by village welfare programmes, local handicrafts and artisan support, rural education. Traditionally unique visual and fine arts, dance-drama-music, open-air schools went hand-in-hand with cutting edge research, development and dissemination in the various sciences, humanities and social-sciences and pan-Indian, Asian and Western languages, literatures and cultures.

Visva-Bharati has a Visitor-the Honourable President of India, a Rector- the Honourable Governor of West Bengal and a Chancellor-the Honourable Prime Minister of India to guide and inspire the stakeholders of the university. The university has as its full-time head the Vice-Chancellor, Registrar and Proctor, Finance Officer; also, the Finance Committee, Librarian and other administrative staff of the university are responsible for the overall academic and administrative functioning of the university. The directors of different Centres being appointed for a fixed period work in association with University Administration. Principals of all ten institutes are at the daily helm of academic and administrative affairs of the university ably assisted by Vice-principals, Heads of Departments and Teachers-in-Charge of Centres. The entire campus is declared a "No-Plastic Zone". Concerning awareness among the university community has been created in campus through signages and posters/boards. Dry- and wet-waste are collected in specified, colored dustbins kept all over the campus. The filled-in bins are shifted time to time by collecting trolleys and then dumped in a specified place located away from the residential and academic areas. The dry/wet degradable waste is then disposed into landfills to produce compost which is used for greening the campus.

E-waste is managed according to the norms of state pollution control board of West Bengal. Recharge pits have been also provided during construction of different hostels, departments etc. Visva-Bharati has implemented open wells to meet its drinking and irrigation water requirements. The rain water from the catchment areas are stored in large and open wells, several ponds inside the campus which are later used for pisciculture, gardening, farming and construction purposes. The harvested water is used as longer-term storage as ground-water recharge. The hospital also properly disposes its waste according to standard procedures. Liquid waste, generated within the campus from kitchen/bathrooms and sewage from the toilets, are drained into septic tanks and soak pits. All buildings at Visva-Bharati have septic tank and soak pit for proper sewage disposal.

Since 2016 Visva-Bharati has been following (and has since internalised and perfected the process) the online automation system related to the examination process which was developed by a third party. Under this system all students and scholars have their own account under this module where they can activate their registration process for each individual semester including the optional courses, pay the examination fees, access their online admit cards to the examinations and partially view their results. Results are published manually and processes to initiate an online documentation of results simultaneously are in place.

All admission procedure to all programmes at Visva-Bharati are controlled and initiated through SAMARTH. Examinations and pre-examinations are also conducted through SAMARTH.

Appointments of all examination related personnel - like examiners, paper-setters, moderators, invigilators - are completed online. Evaluation and re-evaluation are simultaneously completed manually and online to eliminate disparity. Publication of semester and other results, preparation of marksheets, provisional certificates, reports, transcripts, migration certificates and so on are executed through this automated online examination management system. Students have access to their accounts within this system where they are required to fill in their examination forms and they have access to their admit cards and results.

Final year undergraduate students of the Institute of Agriculture are attached to the neighbouring villages under Rural Agricultural Work Experience (RAWEx) programme. The Rathindra Krishi Vigyan Kendra has guided students of several other universities for the RAWEx besides its extensive agro-advisories through on-farm trial, demonstration, trainings and other extension activities. Institute of Rural Reconstruction engaged in extension activities on promotion of rural handicrafts leading to economic empowerment of rural masses as envisaged by Gurudev Rabindranath Tagore. Rathindra Silpa-Mela and Silpotsava Exhibition are organized to congregate artists, designers, craftsmen and local populace to promote handicrafts. Furthermore, Visva-Bharati is dedicated to sensitizing its students to contemporary social issues such as sexual harassment, gender inequality, ecological balance, environmental sustainability, and the rights of differently-abled

individuals across various departments and institutes, fostering a deep connection between education and society. The Central Library, Visva-Bharati also took up a good number of extension activities during this year.

**INFRASTRUCTURE AND LEARNING RESOURCES****4.1 - Physical Facilities**

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

1. Visva-Bharati has eight institutes of higher education and two schools under its academic system. The university has two sprawling connected campuses at Santiniketan and Sriniketan which are scattered and amidst the nature. Visva-Bharati has a unique blend of traditional and smart classrooms and teaching-learning spaces ranging from state of the art laboratories, language laboratories and audio-visual galleries.

2. All institutes have their separate sets of buildings. The playgrounds, basketball courts, tennis courts, gymnasiums, swimming pool, fine-arts studios, performance spaces for dance-

music-drama, computer centre, museums space, libraries, art galleries, auditoriums, audio-visual rooms, audio-visual galleries, seminar and conference rooms, language laboratory, yoga centres, theatre gallery.

3. Apart from computer lab in departments and centres which are used as academic teaching apparatuses, libraries and other e-resource centres are available in the university, The part of teaching learning, website maintenance etc. are done by the Visva-Bharati Computer Centre. In campus MHRD Wi-Fi is available round the clock.

4. Design, graphics, pottery, painting, textile and sculpture spaces and galleries are at par with the best.

1. There are four major university auditoriums including the state of the art Lipika and Bangladesh Bhavana. The traditional NatyaGhar, for many years the staple of functions, programmes and cultural events, is also a major cultural space. There is also an auditorium cum community hall in Sriniketan Maagh Mela is held.

2. The Office of the Dean of Students' Welfare organizes yoga and meditation classes and courses in its own premises for all university student and staff.

3. Visva-Bharati has separate departments dedicated to sports and physical education who have their own multiple play- and activity-areas/arenas including specialised playing fields for various sports, gymnasiums, swimming pool (shared with the university) and courts.

4. In addition, majority of the university hostels - both girls' and boys' - have gymnasiums and limited sporting activity spaces including indoor and outdoor facilities.

5. The core Ashrama area is flanked on one side by the massive KhelaarMaath - playing field - that has been the centre of various activities for over a century. 6. Visva-Bharati has a stadium with galleries with a large playing area that hosts

football, cricket and track-and-field events near the international standard swimming pool adjacent to the physical education departments.

4. Visva-Bharati has over thirty hostels for both boys and girls from students as young as seven years to mature PhD scholars. These hostels are situated all over the two campuses with various styles, architecture, storeys and capacity from as low as thirty to as high as five-hundred. There is a Visva-Bharati General Canteen just inside the core area that caters to both university students and staff as well visitors.

Visva-Bharati has an extraordinarily competent and fully-equipped Engineering Section that looks after all maintenance and repair work, including structural, electrical, waterworks and sewage. Plumbers, engineers, supervisors, electricians and carpenters are always on call. Sanitation and garden departments look after the daily upkeep of the common areas and gardens. The PRO looks after transport facilities, and annual maintenance is done on all vehicles, including ambulances for the hospital. Cleanliness and hygiene of classrooms, seminar halls, toilets/washrooms and shared areas are maintained by women's self-help groups and university employed/outsourced cleanliness and sanitation staff. Laboratories, libraries, hostels, guest houses, gymnasiums, playgrounds, swimming pool, studios and workshops, hospital and emergency facilities, etc. are all looked after by appropriate and competent university authorities who follow standard protocols of maintenance of equipment and facilities as per government rules and equipment usage and instructions. Annual Maintenance Contracts and stock-taking are mandated across the university. Maintenance grants are allotted to all offices for daily upkeep, repairs and related purchases/ installations. Computers, peripherals and upgrades are looked after by individual departments in consultation with the Computer Centre

and its trained staff.

## GOVERNANCE, LEADERSHIP AND MANAGEMENT

### 6.1 - Institutional Vision and Leadership

6.1.1 - The institution has a clearly stated vision and mission which are reflected in its academic and administrative governance

The Visva-Bharati Act, No. XXIX, 1951, and The Statutes of the University and its Amendments very clearly set out the vision and mission of the university that have been the guiding principles behind its long existence. Clause 5A of the Acts - The Objects of the University - unequivocally states that Visva-Bharati will be tasked and mandated with "providing instructional, extension and research facilities and by the example and influence of its corporate life, and the University shall, in organising activities, have due regard to the following objects for which the Visva-Bharati, at Santiniketan was founded by Rabindranath Tagore, as expressed in his own words...". Tagore's ideal way of life was to connect with Man, Nature and Culture across borders and creeds.

Tagore's ideals of rural empowerment through socially holistic and cartographically inclusive endeavours led Visva-Bharati to invest in rural reconstruction and agricultural sciences supported by village welfare programmes, local handicrafts and artisan support, rural education. Traditionally unique visual and fine arts, dance-drama-music, open-air schools went hand-in-hand with cutting edge research, development and dissemination in the various sciences, humanities and social-sciences and pan-Indian, Asian and Western languages, literatures and cultures.

6.1.2 - The effective leadership is reflected in various institutional practices such as decentralization and participative management

Visva-Bharati has a Visitor-the Honourable President of India, a Rector- the Honourable Governor of West Bengal and a Chancellor-the Honourable Prime Minister of India to guide and inspire the stakeholders of the university. The university has as its full-

time head the Vice-Chancellor, Registrar and Proctor, Finance Officer; also, the Finance Committee, Librarian and other administrative staff of the university are responsible for the overall academic and administrative functioning of the university. The directors of different Centres being appointed for a fixed period work in association with University Administration. Principals of all ten institutes are at the daily helm of academic and administrative affairs of the university ably assisted by Vice-principals, Heads of Departments and Teachers-in-Charge of Centres. The Court, the Executive Council, the Academic Council and the departmental level Board-of-Studies are the university's apex statutory bodies that decide upon academic and administrative issues.

Participatory Management is practiced at Visva-Bharati at various levels. There are major realignment of duties of administrative staff all over the various departments and sections on a regular basis. This facilitates overall competence, efficiency and transparency. Academic staff are all given some administrative post or the other during their tenure at Visva-Bharati.

Similarly the income generated from Nandan mela, Silpa Utsav have been used to support the students of the respective departments.

## 6.4.4 - Institution conducts internal and external financial audits regularly

All the expenses incurred by the University and its branches were audited by two different wings of the audit system. The Central audit team, deputed by the Director General performs "TEST CHECKING" of various types of accounts relating to the funds especially received from the UGC, academic receipts and other income. The said audit team also checks balances of stock registers and conducts audit of Library, Works of the Engineering Section and takes responsibility of performing audit of all Plan, Non-Plan and Annual allocation of Expenditure of the University. The Internal Audit makes a thorough pre-audit of the proposals of expenditure both revenue(Non-Salary) and Capital Expenditure of the University. As per statutory provisions (Section 36) of the Visva-Bharati Act, 1951 the annual accounts and balance sheet of the University are prepared under the direction of the Karma-Samiti (Executive Council) and is audited by the C&AG. A copy of the accounts together with audit report is submitted to the Samsad (Court) and the Paridarsaka (Visitor) along with the observation of the Karma-Samiti and may be placed in both the houses of Parliament. The Annual Accounts and Balance report is published in Visva-Bharati website regularly.

The entire campus is declared a "No-Plastic Zone". Concerning awareness among the university community has been created in campus through signages and posters/boards. Dry- and wet-waste are collected in specified, colored dustbins kept all over the campus. The filled-in bins are shifted time to time by collecting trolleys and then dumped in a specified place located away from the residential and academic areas. The dry/wet degradable waste is then disposed into landfills to produce compost which is used for greening the campus.

E-waste is managed according to the norms of state pollution control board of West Bengal. Recharge pits have been also provided during construction of different hostels, departments etc. Visva-Bharati has implemented open wells to meet its drinking and irrigation water requirements. The rain water from the catchment areas are stored in large and open wells, several

ponds inside the campus which are later used for pisciculture, gardening, farming and construction purposes. The harvested water is used as longer-term storage as ground-water recharge. The hospital also properly disposes its waste according to standard procedures. Liquid waste, generated within the campus from kitchen/bathrooms and sewage from the toilets, are drained into septic tanks and soak pits. All buildings at Visva-Bharati have septic tank and soak pit for proper sewage disposal.

### 7.3 - Institutional Distinctiveness

7.3.1 - Highlight the performance of the institution in an area distinct to its priority and thrust (within a maximum of 200 words)

Rabindranath Tagore (1861-1941) who founded the Visva-Bharati in 1921, had envisaged it as a cosmopolitan research centre of knowledge, culture and extension; Rural Reconstruction in Sriniketan was its unique contribution to bringing together higher education and social transformation. Tagore conceptualized a cooperative model in which the latest research in Sriniketan, in agriculture and related subjects, as well as health and sanitation would impact lives of the rural community.

We identify the Department of Lifelong Learning and Extension (Rural Extension Centre) in Sriniketan as this thrust area. The REC's extension and field outreach services includes sixty-five villages, of Bolpur-Sriniketan and Ilambazar Blocks near

Sriniketan. The outreach includes work at the grass root levels with the active participation of local people especially youth and women. Self-Help Groups (SHG), Women's Forums and Brati Balika group of adolescent girls are crucial to this village development projects. The REC addresses questions of health, welfare of infants, education of girls as well as training programmes for rural women making them economically independent through self-employment.

This thrust on women's welfare and sustainable growth has been the focus of work in Sriniketan from the 1920s. It fits in closely with the government's schemes at women empowerment.

### 7.3.2 - Plan of action for the next academic year

1.The preparation of a three phase's roadmap till 2024 of the university in compliance with execution of NEP 2020 is to be completed on priority.

2.To familiarize the online student feedback system and grievance management through SAMARTH portal, an awareness program will be arranged and other effective initiatives will be taken.
