<b>16. Multidisciplinary / interdisciplinary</b>	
<p>The multidisciplinary of Visva-Bharati is grounded in its very mission- " to study the mind of man in its realisation of different aspects of truth from diverse points of view." To this end, the diversity of the faculties and streams in Visva-Bharati comprises Music (Sangit-Bhavana), Arts (Kala-Bhavana), Languages (Bhasha-Bhavana), Humanities and Social Sciences (Vidya-Bhavana), Natural Science (Siksha-Bhavana), Education (Vinaya-Bhavana), Agriculture (Palli Siksha-Bhavana) and Rural Development &amp; Social Work (Palli Samgathana Vibhaga).</p>	

The faculties and streams, moreover, are not isolated but integrated into a broader whole which begins from Gurudev's very concept of Bhrahmacharya which is articulated in the schools of Patha-Bhavana and Siksha-Satra. There, the students are taught about arts, music, nature, society and extension activities at the same time. It is from there that the interdisciplinary of Visva-Bharati germinates.

Later developments, like Integrated Science Education, Studies in European Languages and Cultures as well as the promotion of generic electives courses across Bhavanas have buttressed the multidisciplinary and interdisciplinary aspects of Visva-Bharati. Thus a student of Physics studies music, a student of History studies Fine Arts and a student of Anthropology studies Yoga Arts. Such interdisciplinary is likely to be further enlightened with the adoption of the New Education Policy Curricula 2020.

The IQAC is already in practice to formulate a common curricula plan with regard to NEP 2020. The University has its own NEP 2020 preparation committee which has arranged several meetings with stakeholders for finalization of the NEP 2020.

#### **17.Academic bank of credits (ABC):**

Visva-Bharati has registered in the NAD and also made available some results/mark sheets of odd semesters in the digi-locker of the said portal. Concerned students are entitled to download their results / mark sheets from the portal. Examination section is working on this and trying to complete the work on priority basis.

#### **18.Skill development:**

University has taken a lot of initiatives for the skill development of the villagers, farmers as extension activities. More than 8000 farmers benefited indirectly through farmers' training and Field Day programmes. Around 200 farm women belonging to 67 Self Help Groups (SHGs) were specially trained for the preparation of value added products from pulses such as besan, different kinds of bori, snacks (pakora), sweets and lots of indigenous preparations. Farm youths were also trained for certified seed production of lentils and chickpea with the formation of eight numbers of village based seed enterprises (VBSEs). Along with the doubling of cropping intensity of rice-fallow areas targeted under the project, it has not only increased production and profitability of farmers involved leading to betterment of their livelihood, but also made nutritional security of farm families as well as farm live-stocks with the

availability of pulses, a rich source of protein and minerals, produced on their own lands and useful nutritious bi-products such as bhusha and stover for the livestock. It was demonstrated that farmers could have an additional earning of about ₹40,000/- and ₹50,000/- per annum with the inclusion of lentils and chickpea respectively in rice-fallow mono-cropped areas. Apart from the benefits mentioned above, farmers were also convinced of the impact of pulse crops on soil health improvement in terms of better availability of nutrients particularly nitrogen and phosphorus and better productivity of subsequent kharif rice with saving of nitrogenous fertilizers.

In addition to the above, Palli Samgathana Vibhaga has one music unit which is primarily working for teaching of boys and girls of the surrounding villages adopted by the Visva- Bharati. The Department of Lifelong Learning and Extension (Formerly Rural Extension Centre) actively engaged in improving the conditions of the villagers (around fifty villages) since inception of Sriniketan (1922). The following are the most important extension activities/services through which villagers may get opportunity to learn on some new skill and also update the skill; a) Village Development Societies (VDS); b) Mahila Samities (Women's Forum), c) Brati Organization; d) Self Help Groups (SHGs); e) Rural Library Services; f) Folk Cultural activities; g) Crafts promotion Programs; h) Agricultural extension Activities; i) Continuing education program.

With respect to NEP 2020, the University has designed a number of skill development programme which are in draft mode. The existing nature of University curriculum already explains skill based approach in the teaching-learning process which would be incorporated in the NEP 2020.

### **19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

A repository of the interface between the East and the West, Visva-Bharati has integrated the Indian Knowledge systems in its multifarious activities using the online mode. Apart from online and offline courses on Bengali, Santali, Sanskrit and Pali in its regular curriculum, special certificate courses and online seminars and conferences on Indian culture and languages are regularly held. The Bhasha Bhavana regularly celebrates Hindi Divas and Tulsidas Jayanti

for the promotion of Hindi language and literature in offline and online mode. The Department of Oriya has been recognised as a Centre for Excellence by the Ministry of Tribal Affairs and runs programmes on tribal culture. The Department for Tamil publishes e-books on the learning of Tamil through Bengali. Faculty members of various Departments have designed courses and SLM's for various Universities. The Centre for Endangered Languages has undertaken extensive research and teaching on the Indian endangered languages collecting and archiving data online on 815 languages apart from developing an online tool for transliteration. The Centre for Buddhist Studies has undertaken online programmes to popularise the ideas of Lord Buddha on the campus. In the performative Departments of Sangit Bhavana, regular certificate courses on Hindustani Classical Music and Rabindra Sangeet, various forms of Indian dance have kept the heritage alive through online and offline courses. The same can be said about the teaching of playing instruments like the sitar or the esraj. The two schools of the university Patha Bhavana and Siksha Satra have also organised online awareness programmes and literary meets on Covid 19 and environmental issues. Apart from this, the weekly Upansana and periodic prayer meetings are broadcast online to articulate the Indian philosophical and ethical ideas for students and the public at large.

#### **20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

Visva-Bharati has a well-defined sets of aims and objectives which were framed by Rabindranath Tagore himself almost a century before. All round development of personality followed by social resilience, regional cooperation and international fellowship for establishing global peace were targeted to achieve through education. Accordingly studies in different discipline were introduced in Visva- Bharati since its inception. Studies in Social Sciences, Language, Literature, Culture, Sciences, Agricultural Sciences, Rural Reconstruction, Vocational Education, different forms of performing and visual arts are still in practice in the Visva-Bharati with the target to achieve the initial goals of the University as envisaged by the founder father.

All the departments under the various Bhavanas in the University have defined their course objectives and outcomes in a manner that infuses transparency in the outcome-based learning process. The various programmes and courses not only enhance the employability skills of the students but also their abilities, competencies and life skills. Besides, various departments also offer specific courses for developing generic competencies. Each of these courses

helps in personality development and capacity building of the students and prepares them for various avenues of employment.

Besides, the Department of Environmental Studies also offers an Ability Enhancing Course to generate awareness and sensitivity among the students regarding the environment. Opportunities for Internship, Organizational engagement, field projects are provided by the various academic departments so that the students can have a hand on experience of the subject.

Extension and outreach activities are an intrinsic component of curriculum at Visva-Bharati and several departments under Palli Samgathana Vibhaga, Pali Shikha Bhavana, Vinaya Bhavana, Vidya Bhavana, and Shikha Bhavana offer extension services to the surrounding rural areas. The students are trained in engaging with the community understanding the local challenges and opportunities and involve in problem-solving.

The various departments under Kala Bhavana have designed their curriculum in a manner so as to generate ability of creative thinking among the students and generate an independent body of work. Equally the departments of Sangit Bhavana also framed their curriculum in such a manner that can ensure the development of creativity among the students.

Apart all these the functions and festivals of Visva-Bharati which carries one of the main identities of the university and it is a conscious step taken by Tagore towards harmony and peace of human civilization, which is one of the main objectives of the university from its very inception.

#### 21.Distance education/online education:

There is no distance education in Visva-Bharati. However, the University practiced the online education system through various online platforms during the pandemic.

<b>1.1 - Curriculum Design and Development</b>	

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which is reflected in Programme outcomes (POs), Programme Specific Outcomes(PSOs) and Course Outcomes(COs) of the Programmes offered by the University

Visva-Bharati has been following the Minimum Course Curriculum for undergraduate courses under Choice Based Credit System (CBCS) since the of 2017. All undergraduate departments and teaching units/centres are in sync with this national system at large which, if followed rigorously and adapted indigenously at both national and institutional levels, will allow the nation/institutions to be at par with the best global standards at a pan-Indian range. The CBCS model - partly - has been instituted since then in many other courses and programmes of study at Visva-Bharati.

Individual departments/centres, as well as various discipline clusters, schools, institutes, and other interactive user-provider platforms of the university, have, in the last three years. More since 2017, dealt with the formulation and implementation of various Programme Specific Outcomes (PSOs), Programme Outcomes (POs) and Course Outcomes (COs) in their own unique and enabling ways based upon guidelines from the centre. Course and Programme Objectives have also been re-evaluated and integrated into curriculum revisions and projections. All these are reflected in the syllabi of departments and other teaching and research centres. These are also explained to the students at the beginning of the semester, and many departments also allow parents and guardians to attend these introductory seminars or familiarization processes.

1. Visva-Bharati maintains a balanced approach towards these issues, which are greatly reflected in the curricula across the entire university in various departments, institutes and schools of study.
2. These issues are taught through various courses across all disciplines.
3. The tenets, theories, histories, schools and philosophies on gender, women's studies and ecology and environment are part

of the curriculum, especially in the institutes of literature, social sciences, rural reconstruction, education and the like.

4. There is a dedicated Centre for Women's Studies and a Department of Environmental Science at Visva-Bharati. The Department of Geography has emphasised environment and ecology, especially the local and environmental.
5. Institute of Rural reconstruction and Agriculture teach practical and theoretical courses related to disability studies and women's empowerment, taking a hands-on approach towards sustainable ecological processes in the villages and small towns in and around Santiniketan-Sriniketan.
6. The above issues feature in the Art and Performing arts, where the portrayal of women, nature, and social values are integral and central to the ethos and training paradigms of the art-and-artists at Visva-Bharati.
7. Professional Ethics and plagiarism are taught at the MPhil and PhD levels.

**2.2 - Catering to Student Diversity**

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

1. Visva-Bharati has in place an internal assessment system that is held continuously throughout the semester, where students are assessed to the tune of 20% of their academic assessment for that particular semester. At least two assessments are made internally for each paper in each semester. Various other holistic, nurturing and academic counselling are established for the students.
2. The modes of evaluation include class presentation and viva-voce, where the teachers can gauge the individual student face-to-face. Continuous corrective measures are in place at all departments.
3. Remedial classes and programmes are already in place in Visva-Bharati and met with varying degrees of success. Tutorials and a mentoring system within the department comprising teachers and senior students is in place. Periodic stock-taking among teachers and meetings with class-representatives on progress of academic calendar means that a process of feedback is in place at the microcosmic level in all academic departments and centres.
4. Teachers regularly provide them institutional access to various e-resources through libraries and online journal sites, journals, instructional videos, reading material and the like.
5. Joint collaborative courses and studio/laboratory work in science, agriculture, visual-arts, journalism as well as other disciplines are regularly done.

### 2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

1. The various departments of agricultural studies and social reconstruction programmes, as well as education departments and institutes, have strict students' participation in teaching and assistance roles at various levels of socio-academic interaction. Students act as mentors and guides with farming communities and villages and double as secondary - often primary - sources of knowledge and skills.
2. Multidisciplinary studies and courses, seminars, workshops, conferences, meet-the-author/sportsperson/painter/musician/scientist/special lectures are all integral part of the semester system at Visva-Bharati.
3. Project-work, academic collaborations and social-awareness programmes with students and teachers are constantly being organised at the various institutes and schools of study at Visva-Bharti.
4. Visva-Bharati has a large number of social and cultural events and utsavs and Student participation in these activities is part of the curricula at these departments/institutes.
5. Students are often academically challenged and pushed beyond syllabi boundaries that make them appreciate the added edge and strongly prepare them for the future ahead of them.

### 2.3.2 - Teachers use ICT enabled tools including online resources for effective teaching and learning processes during the year

1. Most departments have multiple LCD projectors and audio-visual display systems in place in classrooms and other academic spaces so that students may be given a multimedia accessible dissemination paradigm that is in sync with global standards.
2. More ICT enabled classrooms/seminar halls/conference halls/laboratories are quickly coming up and the various libraries at Visva-Bharati have already geared up by making their holdings digitized and accessible online through various platforms with access to online journals and e-resources like INFLIBNET for students, teachers, research scholars and visitors. The majority of the examination processes and admission tests this extended semester were carried out on the internally maintained Moodle platform which is also a major destination for online classes, tests and other teaching-learning activities.
3. Submission of internal assessments, MPhil and PhD presentations and pre-submission presentations as well as the Viva-voce are all being held online now with facilities being upgraded centrally through the Computer Centre (Ganitra Sadana) and the Central Library.
4. Every Institute in Visva-Bharati has been equipped with one Smart Class room.

## INFRASTRUCTURE AND LEARNING RESOURCES

### 4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

1. Visva-Bharati has eight institutes of higher education and two schools under its academic system. The university has two sprawling connected campuses at Santiniketan and Sriniketan which are scattered and amidst the nature. Visva-Bharati has a unique blend of traditional and smart classrooms and teaching-learning spaces ranging from state of the art laboratories, language laboratories and audio-visual galleries.

2. All institutes have their separate sets of buildings. The playgrounds, basketball courts, tennis courts, gymnasiums, swimming pool, fine-arts studios, performance spaces for dance-music-drama, computer centre, museums space, libraries, art galleries, auditoriums, audio-visual rooms, audio-visual galleries, seminar and conference rooms, language laboratory, yoga centres, theatre gallery.

3. Apart from computer lab in departments and centres which are used as academic teaching apparatuses, libraries and other e-resource centres are available in the university, The part of teaching learning, website maintenance etc. are done by the Visva-Bharati Computer Centre. In campus MHRD Wi-Fi is available round the clock.

4. Design, graphics, pottery, painting, textile and sculpture spaces and galleries are at par with the best.

1. There are four major university auditoriums, including the state-of-the-art Lipika and Bangladesh Bhavana. The traditional NatyaGhar, for many years the staple of functions, programs and cultural events, is also a major cultural space. There is also an auditorium cum community hall in Sriniketan Maagh Mela is held.
2. The Office of the Dean of Students' Welfare also regularly organizes yoga and meditation classes and courses on its own premises for all university students and staff.
3. Visva-Bharati has separate sports and physical education departments with their own multiple plays- and activity-areas/arenas, including specialised playing fields for various sports, gymnasiums, and a swimming pool (shared with the university) and courts.
4. In addition, most university hostels - girls' and boys' - have gymnasiums and limited sporting activity spaces, including indoor and outdoor facilities.
5. The core Ashrama area is flanked on one side by the massive KhelaarMaath - playing field - that has been the center of various activities for over a century.
6. Visva-Bharati has a stadium with galleries with a large playing area that hosts football, cricket, and track-and-field events near the international standard swimming pool adjacent to the physical education departments.

Visva-Bharati has an extraordinarily competent and fully-equipped Engineering Section that looks after all maintenance and repair work, including structural, electrical, waterworks and sewage. Plumbers, engineers, supervisors, electricians and carpenters are always on call. Sanitation and garden departments look after the daily upkeep of the common areas and gardens. The PRO looks after transport facilities, and annual maintenance is done on all vehicles, including ambulances for the hospital. Cleanliness and hygiene of classrooms, seminar halls, toilets/washrooms and shared areas are maintained by women's self-help groups and university employed/outsourced cleanliness and sanitation staff. Laboratories, libraries, hostels, guest houses, gymnasiums, playgrounds, swimming pool, studios and workshops, hospital and emergency facilities, etc. are all looked after by appropriate and competent university authorities who follow standard protocols of maintenance of equipment and facilities as per government rules and equipment usage and instructions. Annual Maintenance Contracts and stock-taking are mandated across the university. Maintenance grants are allotted to all offices for daily upkeep, repairs and related purchases/ installations. Computers, peripherals and upgrades are looked after by individual departments in consultation with the Computer Centre and its trained staff.

## GOVERNANCE, LEADERSHIP AND MANAGEMENT

### 6.1 - Institutional Vision and Leadership

6.1.1 - The institution has a clearly stated vision and mission which are reflected in its academic and administrative governance

The Visva-Bharati Act, No. XXIX, 1951, and The Statutes of the University and its Amendments very clearly set out the vision and mission of the university that have been the guiding principles behind its long existence. Clause 5A of the Acts - The Objects of the University - unequivocally states that Visva-Bharati will be tasked and mandated with "providing instructional, extension and research facilities and by the example and influence of its corporate life, and the University shall, in organising activities, have due regard to the following objects for which the Visva-Bharati, at Santiniketan was founded by Rabindranath Tagore, as expressed in his own words...". Tagore's ideal way of life was to connect with Man, Nature and Culture across borders and creeds.

Tagore's ideals of rural empowerment through socially holistic and cartographically inclusive endeavours led Visva-Bharati to invest in rural reconstruction and agricultural sciences supported by village welfare programmes, local handicrafts and artisan support, and rural education. Traditionally unique visual and fine arts, dance-drama-music, and open-air schools went hand-in-hand with cutting-edge research, development and dissemination in the various sciences, humanities and social sciences and pan-Indian, Asian and Western languages, literatures and cultures.

Visva-Bharati has a Visitor-the Honourable President of India, a Rector- the Honourable Governor of West Bengal and a Chancellor-the Honourable Prime Minister of India to guide and inspire the stakeholders of the university. The university has as its full-time head the Vice-Chancellor, Registrar and Proctor, Finance Officer; the Finance Committee, Librarian and other administrative staff of the university are responsible for the overall academic and administrative functioning of the university. The directors of different Centres being appointed for a fixed period work in association with University Administration. Principals of all ten institutes are at the daily helm of academic and administrative affairs of the university, ably assisted by Vice-principals, Heads of Departments and Teachers-in-Charge of Centres. The Court, the Executive Council, the Academic Council and the departmental level Board-of-Studies are the university's apex statutory bodies that decide upon academic and administrative issues.

Participatory Management is practised at Visva-Bharati at various levels. There are major realignments of duties of administrative staff all over the various departments and sections on a regular basis. This facilitates overall competence, efficiency and transparency. Academic staff are all given some administrative post or the other during their tenure at Visva-Bharati.

1. To begin with, there are ten that are autonomous to an extent to decide upon their academic and administrative daily running. Departments have their own various committees including the Department Committee to decide upon a number of academic and administrative issues, Various departments are governed by Boards of Studies of each department are the highest set of department level decision making sites followed by Institute Board and then Research Boards of all institutes.
2. The Academic Council and the Executive Council are the highest

decision-making committees as far as academic and administrative affairs. The Samsad (Court) is the highest decision-making body of the entire university, which is an all-compassing body.

4. Junior/mid-level faculty members are tasked with many time-bound centrally derived committees and positions (Teacher-Wardens, Deputy Proctors, Deputy Dean of Students' Welfare, Vice-Principals, NSS and NCC Coordinators).

The University Court is the supreme authority of the University. The Court meets once every year. The Academic Council consists of senior faculty members and academic experts. The Registrar is the administrative head of the University. The administrative services are further divided into Admissions and Exams; Academic & Research; Finance; Accounts; General Administration; Planning; IQAC; ICC & Anti-ragging Cells; Computer Centre & IT Services; SC/ST Cell, Library, Hospital, Public Relations, Grievance Cell (Student and Employee) and the like.

The Organograms has been presented to understand the details of the roles and policies of the institute.

The Chief Medical Officer looks after the smooth functioning of the University hospital. The university has an Advisor, Foreign Students, who looks after students' responsibility for international

affairs. The Librarian promotes the latest developments in the field of e-learning.

Services at PMH include emergency, indoor patients' care and minor surgeries. Superannuated university members also have access to medical care at the PMH.

The profit generated from this mela has been used to support the needy students of the students of Patha Bhavana. Similarly, the income generated from Nanda-Nadan mela, and Silpa Utsav have been used to support the students of the respective departments.

#### 6.4.4 - Institution conducts internal and external financial audits regularly

All the expenses incurred by the University and its branches were audited by two different wings of the audit system. The Central audit team, deputed by the Director General, performs "TEST CHECKING" of various accounts relating to the funds, especially those received from the UGC, academic receipts and other income. The said audit team also checks balances of stock registers and conducts an audit of Library, and Works of the Engineering Section and takes responsibility of performing an audit of all Plan, Non-Plan and Annual allocations of Expenditure of the University. The Internal Audit makes a thorough pre-audit of the proposals of expenditure both revenue(Non-Salary) and Capital Expenditure of the University. As per statutory provisions(Section 36) of the Visva-Bharati Act, 1951 the annual accounts and balance sheet of the University are prepared under the direction of the Karma-Samiti(Executive Council) and is audited by the C&AG. A copy of the accounts, together with the audit report is submitted to the Samsad(Court) and the Paridarsaka (Visitor) along with the observation of the Karma-Samiti. It may be placed in both houses of Parliament. The Annual Accounts and Balance report is published in the Visva-Bharati website regularly.

**The entire campus is declared a "No-Plastic Zone" and necessary awareness has been created in the campus through signage and posters/boards.**

**Dry- and wet-waste are collected in specified dustbins placed all over the campus and are shifted to collecting trolleys and then dumped in a specified place located away from the residential and academic areas. The dry/wet degradable waste is disposed into landfills to produce compost which is used for greening the campus.**

**E-waste is managed according to the norms of state pollution control board of West Bengal. Recharge pits have been also provided during construction of different hostels, departments etc. Visva-Bharati makes use of open well to meet its drinking and irrigation water requirements. The rain water from the catchment areas are collected in large and open wells, several ponds in the campus which are used**

for pisciculture, gardening, farming and construction purposes. The harvested water is used as longer-term storage as ground-water recharge.

The hospital also properly disposes its waste according to standard procedures.

Liquid waste generated within the campus from kitchen/bathrooms and sewage from the toilets are drained into septic tanks and soak pits. All buildings at Visva-Bharati have septic tank and soak pit for sewage disposal.
