Prof. Bidyut Chakrabarty, Vice-Chancellor and Chairperson, IQAC presided over the meeting. Meeting started with welcome address by the Vice-Chancellor and introduction with all the members. At the outset, Prof. Chakrabarty made some comments on his observation relating to evaluation of CAS applications, like plagiarism and disparity about calculation of scores on teaching. Prof. Rup Kumar Kar, Director, IQAC read the minutes of the earlier IQAC meeting held on 25.08.2018 and discussed followed oy confirmation.

Resolutions:

Minutes of the earlier meeting were read and confirmed.

Regarding the processing of CAS applications (in 2016 format) submitted against last notification it is decided that the screening of these applications may be initiated in the office of the Principal of respective Bhavanas as soon as possible. Screening-cum-Evaluation Committee will be constituted as per UGC Guidelines (Base guidelines of 2010 with amendments made later) comprising of (i) Vice-Chancellor or his nominee as Chairperson, (ii) Principal of the Bhavana as member, (iii) Head of the Department as member, (iv) External Expert from outside University/Institute as nominated by Vice-Chancellor from a panel of Experts. In addition, the Committee will also include one Senior most Professor of the Department as invitee and two other invitee members nominated by Vice-Chancellor to assist in calculating score. After screening of the applications these forms along with all documents including best papers (three or five in case of applications

for Associate Professor or Professor, respectively) and recommendation of the Committee are to be sent directly to the office of Assistant Registrar (Establishment) for further processing. In this connection, to prevent the cases of possible plagiarism an Undertaking/Declaration in a prescribed format will be sought from all the applicants and these have to be submitted during interview (for candidates who have applied earlier and are awaiting selection) or to the office of Principal of respective Bhavanas (for candidates who have applied against the last notification).

- 3. Principals of all the Bhavanas of Visva-Bharati will be again requested to process and subsequently send the pending CAS applications, if any, of faculty members of their respective Bhavana positively by 20.03.2019.
- 4. Regarding next notification inviting applications for CAS promotion (in 2018 format) it is proposed to be done tentatively by the end of April, 2019.
- 5. If anyone applied for CAS promotion to a stage in the earlier spell but has qualified by this time for the next stage upon maturity of the required period, the second application will be processed only after the successful placement in the earlier stage, in case he/she applied for both the stages together.
- Regarding preparation of Annual Quality Assurance Report (AQAR) for the year 2017-18 progress in this regard has been discussed and Dr. Subhasree Sanyal has been requested to consult with the newly created University Statistics Cell under the office of Establishment for further necessary action.
