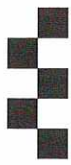

**Offer of Appointment**

Dear Sir,

We are glad to inform you that Prof. R. Siva Kumar, Professor of History of Art, Kala Bhavana, Visva Bharati, Santiniketan, has been selected for deputation as the Visiting Professor to ICCR Chair of Indian Studies at Carleton University, Canada, for a period of one semester commencing from 1<sup>st</sup> week of January, 2018. The terms and conditions of your deputation would be as follows:-

a. **Tenure:-** The period of deputation will commence from the date he joins the University and ends on the day he is relieved from the institute. The deputationist is entitled for the preparation/ joining time of up to 7 days at the time of commencement and completion of tenure, during which he should report to ICCR to sign his joining report/relieving report. If there is any gap between the date of signing the joining report/ relieving report and joining his parent University, it should be regularized by the latter under applicable rules.

b. **Obligations:-**

(i) Obligation of Prof. R. Siva Kumar will be in accordance with the MoU signed between ICCR and Carleton University, Canada.

(ii) Prof. R. Siva Kumar will teach course at the Carleton University in consultation with the Carleton University, Canada.

(iii) Prof. R. Siva Kumar will finalize the curriculum/course in consultation with the Carleton University, Canada.

(iv) Prof. R. Siva Kumar will deliver at least one public lecture during the semester to be arranged by the University, which would be termed as "ICCR Lecture on India".

(v) **Conduct and performance:-** The Visiting Professor will abide by the host University's code of conduct and human resources policies and laws of the country for deputation.

(vi) **Employment of Spouse and Family members:-** The spouse of Prof. R. Siva Kumar and dependent family members if residing with him shall not accept any employment in Canada, on payment basis without prior permission of the ICCR, who will consider such proposals only if recommended by the concerned Mission/Post and in consultation with the Ministry of External Affairs, when necessary. **(Note- All expenditure on accompanying spouse and family members will be borne by Prof. R. Siva Kumar himself.)**

c. **Pay & other remuneration payable by ICCR:-**

(i) During the period of deputation, Prof. R. Siva Kumar will draw from the relevant Mission/Post the same basic pay and grade pay as is being drawn by him in the present scale of pay in parent organization, with annual increments to the next higher stages in the scale.

(ii) No other allowance, including deputation duty allowance, servant wages EWF charges, will be admissible.

(iii) The Quantum of Additional Allowance admissible will be determined on the basis of the country of deputation. The Quantum of Additional Allowance once fixed, will remain unchanged for the duration of the deputation and will not be affected by any revision of pay scales/grade pay on account of annual increment, promotion or grant of ACPs or any other factors.

(iv) Further, the amount/honorarium being paid by the University under the MoU with ICCR would be deposited in the Mission.

(v) Grant of leave will be regulated in terms of relevant provisions of IFS (PLCA) Rules.

(vi) Prof. R. Siva Kumar will not accept any other remuneration other than as provided in this letter and in the MoU while on deputation.

d. **Pension/Provident Fund:-** During the period of deputation, Prof. R. Siva Kumar will continue to be governed by the rules of the Visva Bharati, Santiniketan, West Bengal, relating to the pension/provident fund etc. The Mission/Post will remit employers subscription to the provident fund by RBI drafts through deduction from the monthly salary bill to his parent institution under intimation to the ICCR.

e. **Leave:-**

(i) During the period of deputation Prof. R. Siva Kumar will be entitled for 2 ½ days earned leave for each completed month of service and a maximum of 8 days casual leave in a calendar year. For lesser periods of deputation, casual leave would be calculated proportionately. No leave salary contribution will be paid by the Council.

(ii) Any additional leave requested and granted by ICCR to Prof. R. Siva Kumar will be treated as extraordinary leave without pay.

(iii) Grant of leave will be regulated in terms of relevant provisions of IFS (PLCA) rules. The leave request should be routed through the relevant Head of Mission/Post to ICCR.

(iv) He will not apply for any kind of leave to the parent institution/University in India and will not carry over any credit of un-availed leave on return.

**f. Passage & Baggage Allowance:-**

(i) Prof. R. Siva Kumar will be provided to and fro international air passage the cheapest economy class and shortest route for himself only and 100 kgs unaccompanied baggage allowance exclusive of free baggage allowance provided by the airline.

(ii) The return passage will be available only on completion of assignment.

(iii) Prof. R. Siva Kumar is not entitled for any other passage to India or any other destination at the cost of ICCR during the entire period of his deputation. The ICCR will not bear any expenses related to premature return of Prof. R. Siva Kumar to India under any circumstance.

**g. Other facilities to be provided during the stay of the Visiting Professor abroad:-**

(i) Accommodation, medical care, office space and other facilities will be on the basis of the MoU signed between ICCR and the Carleton University, Canada.

(ii) Where the University is not responsible for providing either accommodation or medical coverage, the same would be the responsibility of ICCR.


(iii) Where the university is responsible for medical coverage, ICCR will not be liable for any additional medical expenses over and above what is being provided by the University/Institution.

**i. Settlement of final dues:-** The final dues on his return will be settled only after receiving Performance/Assessment Report from the concerned University and the Mission.

**j. Recall:-** If circumstances arise which necessitate termination of appointment of Prof. R. Siva Kumar the decision thereof would be taken by ICCR in consultation with the Carleton University, Canada.

Any matter not covered above will be referred to ICCR whose decision will be final.

The appointment will be subject to the formal acceptance of the terms and conditions of the offer detailed in this letter by Prof. R. Siva Kumar with the formal concurrence of his parent institution. Prof. R. Siva Kumar is required to join the ICCR in **January, 2018**. However, the exact date from which his services are required will be intimated in due course on receipt of concurrence from him. We shall be grateful the formal acceptance of this offer with formal concurrence of your institution is sent to us latest by **5<sup>th</sup> November, 2017**, so that we may proceed further in the matter.

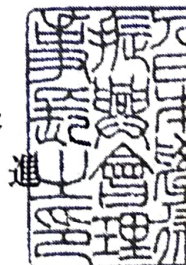

2. Title of Research : Magnetic and thermodynamic studies of metal assembled compounds
3. Working Hours : 40 hours per week
4. Period of Employment : September 1, 2015 to November 30, 2015  
(For Three months)
5. Salary : A salary of 632,000 yen per month shall be provided on the legally appointed day in each month.

In case the period of employment starts or terminates on a day which is not the first or last day of the month, the aforesaid payment shall be computed on a daily basis.

In addition thereto, commutation allowances shall be provided in accordance with the regulations pertaining to Osaka University Visiting Research Scholar.

6. Housing : Accommodation equipped with furniture and appliances will be arranged. Any fees and necessary expenses associated with the use of such accommodations, including utility fees for electricity, gas, and water, shall be the responsibility of the tenant.

Further details shall be stipulated separately.

7. Travel Expenses and others :

(1) Airplane fares on a regular economy class flight and railway fares, both by means of the shortest route from your present domicile to Osaka University; daily and hotel allowances at a fixed official rate; inoculation fees, passport and visa application charges, currency exchange fees, and immigration taxes shall be refunded in net in terms of yen after your arrival at Osaka University.

Reimbursement of the aforesaid inoculation fees, passport and visa application charges, currency exchange fees, and immigration taxes shall depend on the presentation of the receipts thereof.

(2) In case you return to your home country within 3 months after the day of expiration of employment, travel and other expenses shall be provided on the same basis as stated above at the time of your departure from Osaka University.

## Qualification for Membership and Application Procedure

Membership in the IAU is open to countries (National Membership) and individuals (Individual or Junior Membership). The procedures for submission and approval of applications in the two categories are described in the IAU Working Rules ([§ II and III](#)). A brief summary of the procedure for seeking nomination for IAU Individual or Junior Membership is given below.

*Please note that a new category of membership, the **Junior Member** has been approved at the IAU XXX General Assembly (August 2018). Now researchers who have just completed their PhD in a branch of astronomy/astrophysics can be proposed as IAU Junior Member. The admission of new **Junior Members** will be evaluated annually by the [Membership Committee](#) and approved by the [Executive Committee](#). Junior Membership is temporary and cannot be extended for more than six years.*

- **IAU Individual or Junior Membership: Nomination of a candidate residing in a National Member country**

As a rule, Individual Membership in the IAU is open to scientists with a PhD or equivalent in a branch of astrophysics.

Junior Membership is open to individuals who have completed the PhD studies and who are in the initial phase of the professional researcher career in some branch of astronomy.

An **Individual or Junior Member** may be admitted to the IAU by the Executive Committee on the basis of nominations approved by the National Committee for Astronomy ([NCA](#)) in their **country of employment** (when no NCA exists, through the Adhering Organization in that country).

Individuals applying for nomination for IAU **Individual or Junior Membership** should contact their [NCA or Adhering Organization](#) (whichever applies) in their country of work in order to receive the link to the application form. This should be done before **December 15th, 2020**, so that these applications can be processed for approval in time for their submission to the IAU (see below). The call for membership applications to be submitted is open as of **October of 2020**. Individual and Junior Membership applications are submitted annually.

The procedure is electronic, via forms made available by the IAU to the NCAs, or to the Adhering Organizations. For reference, the forms include the full name, date and place of birth, and nationality of the candidate; postal and electronic addresses; the University, year, and subject of the Ph.D. or equivalent degree; the current affiliation and occupation, and the IAU Division(s) which the candidate wishes to join, 1 letter/document from the department granting the PhD, a list of past publications plus any additional information required by the NCA or Adhering Organization.
