AGREEMENT FOR GRANT OF ENDOWMENT

This Agreement for Grant of Endowment ("Agreement") is entered into in Mumbai on 18<sup>th</sup> March 2020 ("Effective Date") by and between

(1) ARUNA ADVANI, an Indian Inhabitant residing at C – 7, Rashmi Cooperative Housing Society Ltd, 11 Byramjee Gamadia Road, Mumbai 400026 (2) NILIMA SHEIKH, an Indian Inhabitant residing at Niharika, Behind University, Health Club, Pratapgunj, Vadodara 390002, (3) RAMAN SIVAKUMAR, an Indian Inhabitant residing at Surmaya, South Pearsonpalli Santiniketan, West Bengal 731235, (4) SHEILA MAKHIJANI, an Indian Inhabitant residing at C – 57, Mayfair Garden, New Delhi 110016, (5) VIDYA SHIVADAS, an Indian Inhabitant residing at E – 1, Press Enclave. Saket, New Delhi, 100017, (6) BHARATISHARMA, an Indian Inhabitant residing at B – 42, Friends Colony West, New Delhi 110065, (7) TANYA HALINA ADVANI, an Indian Inhabitant residing at C – 7, Rashmi Cooperative Housing Society Ltd, 11 Byramjee Gamadia Road, Mumbai 400026, in their capacities as the Trustees of the Mrinalini Mukherjee Foundation ("Trust"), a trust established under the Maharashtra Public Trust Act, 1950 and under Trust Deed dated 21 December 2015 having its office at C – 7 Rashmi CHSL, 11 Byramjee Gamadia Road, Off Carmichael Road, Mumbai 400 026 hereinafter collectively referred to as the "Trustees", (which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include, the trustee or trustees for the time being of the Trust);

**VISVA-BHARATI**, a Central University established by the Visva-Bharati Act, 1951 (Central Act XXIX of 1951), having its office at Santiniketan, Birbhum, West Bengal - 731235, hereinafter referred to as the “**University**” (which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns).

The University and the Trust are individually referred to as a “**Party**” and collectively, as the “**Parties**”.

**WHEREAS:**

- A. Mrinalini Mukherjee was the owner of certain art works (“**Works**”) created by her father, Late Benode Behari Mukherjee (“**Artist**”).
- B. The University was founded by the late Rabindranath Tagore at Santiniketan in the district of Birbhum in West Bengal. Kala Bhavana is the fine arts faculty of the University and is a noted institution of education and research in visual arts. The Artist was a student of Kala Bhavana and later joined back as a member of its teaching faculty.
- C. Upon Mrinalini Mukherjee’s demise and in accordance with her last will and testament dated 2nd April 2014 (the “**Will**”), the Estate of Late Mrinalini Mukherjee (“**Estate**”) executed an agreement dated 01<sup>st</sup> December 2017 with the University, whereby the Estate donated the Works to the University on the terms and conditions set out therein (“**Artwork Donation Agreement**”).
- D. Pursuant to the Artwork Donation Agreement, the Trustees are desirous of granting an amount of Rs.2,00,00,000/- (Rupees Two Crore only) (by an endowment and funding) to the University for the conservation, promotion and exhibition of the Works and matters ancillary thereto upon the terms and conditions set out herein.

**IT IS AGREED BY THE PARTIES AS FOLLOWS:**

**1. Grant of Endowment**

- (a) The Trust hereby agrees to grant to the University, and the University hereby agrees to accept from the Trust, an endowment of Rs.2,00,00,000/- (Rupees Two Crore only) to be utilised by the University through Kala Bhavana for the purposes and upon the terms contained herein (“**Endowment**”).
- (b) Payment of the lumpsum amount of the Endowment will be sent to the University / Kala Bhavana upon receipt of an executed copy of this Agreement and related documents, indicating that the University accepts the terms and conditions of this grant.
- (c) The Endowment shall be granted vide bank transfer to the account of Visva-Bharati University vide Account Number 00000010598447157 of State Bank of India, Santiniketan Branch, Birbhum, West Bengal-731235, CIF No. 80469252314, IFS Code SBIN0002121, MICR Code 731002003.

**2. Purpose and Distribution**

- (a) The Endowment shall be distributed and utilised by the University as per the limits and in the manner provided below:

- (i) Rs.50,00,000/- (Rupees Fifty Lakh only) from the Endowment shall be utilised by Kala Bhavana for the upkeep of the Works donated to the University under the Artwork Donation Agreement;
- (ii) Rs.50,00,000/- (Rupees Fifty Lakh only) from the Endowment shall be utilised by Kala Bhavana for supporting the Benode Behari Mukherjee Archives and Research Centre including for undertaking archival documentation projects, providing facilities to researchers, extension activities through lectures, discussions etc.;
- (iii) Rs.60,00,000/- (Rupees Sixty Lakh only) from the Endowment for salaries of two persons to be appointed by the University for a period of 5 (five years) to undertake the documentation and archiving of the Works at the Benode Behari Mukherjee Archives & Research Centre;
- (iv) Rs.40,00,000/- (Rupees Forty Lakh only) from the Endowment towards building the necessary infrastructure at/for the Benode Behari Mukherjee Archives & Research Centre.
- (b) Distributions from the Endowment shall be committed, granted or expended in accordance with the provisions of this Agreement. The University shall honour the conditions or restrictions imposed upon it by the Trust as to the thresholds and purpose of use, subject, however, to the authority of the Trust to vary the terms of this Endowment if continued adherence to any condition or restriction is in the judgment of the University and the Trustees unnecessary, incapable of fulfilment or inconsistent with the needs of Kala Bhavana and/or the University read with the object of the Trust. No distribution shall be made from the Endowment to any individual or entity if such distribution is contrary to the terms hereof.
- (c) The bank interest accrued on the limits of the Endowment set out in Clause 2(a) above shall also be allocated for the same purposes in the applicable proportions.

### 3. Accounting

- (a) Notwithstanding anything to the contrary, the University shall hold the Endowment subject to the provisions of the applicable laws.
- (b) The University shall monitor the distribution of the Endowment and agrees to provide the Trustees a copy of the statement of accounts prepared by the independent auditors of the University on an annual basis, indicating the distribution of the Endowment, together with such other details as the Trustees may require, in accordance with the terms hereof.
- (c) The receipts and disbursements of this Endowment shall be accounted for separately and apart from those of other donations / grants / endowments to the University.

### 4. Warranties

- (a) The University hereby represents and warrants that:
- It is duly established by the Visva-Bharati Act, 1951 and is governed by the Statutes, Ordinances and Regulations made there under. It is validly existing in accordance with the laws of India;
  - It has power to enter into and perform this Agreement and it has taken all necessary corporate and other action to authorise the execution, delivery and performance of this Agreement.

- The execution, delivery and performance of this Agreement will not contravene any applicable law or regulation to which the University is subject or any provision of the constitutional documents of University or any agreement or obligation or document binding on or applicable to it and all approvals requisite for such execution, delivery and performance are as on the date of this Agreement in full force and effect and shall continue to be so during the currency of the Agreement;
- This Agreement constitutes legally binding and enforceable obligations of the University;
- It shall perform its obligations under this Agreement.
- It shall not misuse, misappropriate or otherwise deal with the Endowment in any manner contrary to the terms of this Agreement and/or the object of the Trust;

#### 5. Term

This Agreement shall continue to remain in force from the date of execution until the date of distribution and utilisation of the Endowment in full (together with all interest earned therefrom) in the manner contained herein or the termination hereof.

#### 6. Indemnity

The University shall indemnify and agrees to keep indemnified the Trust, its Trustees, the Executrix, the its/her agents and representatives (“**Indemnified Parties**”) and hold them harmless against any Losses which any or all of the Indemnified Parties suffers, sustains, incurs, becomes subject to or pays off and which arises out of or results from (i) any breach of the warranties, covenants, terms and conditions and/or obligations of the University set out herein, and (ii) the University’s unlawful disclosure, use, or misappropriation of the Trustees’, Trust’s or any third party’s confidential information, and/or (iii) any claims, actions, suits, and/or proceedings brought or instituted against the Trustees or the Trust relating to the Works and/or Endowment; (iv) misuse, misappropriation or any other default or breach in the distribution or utilization of the Endowment.

For the purpose of this clause, “**Losses**” means all losses, liabilities, taxes, suits, actions, proceedings, judgments, orders, deficiencies, damages, claims, expenses, charges or costs (including reasonable legal expenses), assessments, interest, fines and penalties.

#### 7. Events of Default

In the event:

- It is or becomes unlawful for the University to perform any of its obligations under this Agreement or the Artwork Donation Agreement;
- Any actions, claims or proceedings brought against the Trustees and/or the University which adversely affects any Work and/or the Endowment and/or the Trustees in any prejudicial manner whatsoever;
- The University permanently shuts down the exhibition of the Works or the Benode Behari Centre or is of the opinion that it is not in a position to disburse the Endowment in the manner provided herein;

- There occurs an event of Force Majeure that is likely to affect or has adversely affected the Works, the Benode Behari Centre and/or the disbursement of the Endowment in any manner whatsoever;
- The University commits a default, breach of or non-compliance with any representations, covenants, obligations, duties etc. under this Agreement notwithstanding anything contained in this Agreement;

then, the University shall forthwith inform the Trustees in writing of the occurrence of the same and thereupon, at the discretion of the Trustees, deliver all the Works to the Trust or to such other entity / person as the Estate may decide and refund all unutilised amounts of the Endowment, within one (1) month of receipt of such instructions.

## 8. Notices

Any notice or other communication that may be given by one Party to the other shall always be in writing and shall be served either by (i) hand delivery duly acknowledged, (ii) sent by registered post with acknowledgement due, or (iii) by e-mail at the respective addresses set out herein below or at such other address as may be subsequently intimated by one Party to the other in writing as set out herein:

All notices shall be deemed to have been validly given on the business date of receipt, if sent by registered post or hand delivery.

## 9. Dispute Resolution

In the event a claim, dispute or difference arises out of or in connection with this Agreement (“Dispute”), the Parties shall make all reasonable efforts to resolve the dispute amicably through good faith discussions. If the Parties fail to resolve the Dispute within ten (10) days from the date of receipt of a written notice of the Dispute by the notifying Party, then such Dispute shall be referred to arbitration in accordance with the provisions of the Arbitration and Conciliation Act, 1996 or any statutory modification or re-enactment thereof for the time being in force by a sole arbitrator to be jointly appointed by the Parties. The arbitral proceeding shall be conducted in English in Mumbai. The costs for arbitration shall be borne equally by the Parties. The arbitration

award of the arbitrators shall be final and binding on the Parties and shall be enforceable in accordance with its terms. The arbitrator shall state reasons for his/her findings in writing. The Parties agree to be bound thereby and to act accordingly.

**10. Governing Law and Jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of India, without giving effect to its conflict of law principles. Each of the Parties hereto consents to the exclusive jurisdiction and venue of the courts of Mumbai, India.

**11. Entire Agreement and Modification**

This Agreement constitutes the entire agreement of the Parties and supersedes all prior agreements and understandings, both written and oral, amongst the Parties with respect to the subject matter hereof. This Agreement may be modified only by a written instrument signed by the Parties.

**12. Assignment**

The terms of this Agreement shall bind the University and the Trustees and their respective successors and assigns. The University shall not be entitled to assign this Agreement, in whole or in part to any other party. The Trust shall, in its sole discretion, be entitled to assign this Agreement, in whole or in part to such other party, person or entity.

**13. Severability**

If one or more provisions of this Agreement are held to be unenforceable under applicable law, the Parties agree to renegotiate such provision in good faith. In the event that the Parties cannot reach a mutually agreeable and enforceable replacement for such provision, then (i) such provision shall be excluded from this Agreement, (ii) the balance of the Agreement shall be interpreted as if such provision were so excluded and (iii) the balance of the Agreement shall be enforceable in accordance with its terms.

**14. Waiver**

No omission or delay on the part of the Trustor Trustees in requiring a due and punctual fulfilment by the University of the obligations of the University under this Agreement shall be deemed to constitute a waiver by the Trust or the Trustees of any of their rights to require such due and punctual fulfilment and, in any event, shall not constitute or be construed as a continuing waiver and/or as a waiver of other or subsequent breaches of the same or other (similar or otherwise) obligations hereunder, or as a waiver of any remedy the Trust or Trustees might have. Any term of this Agreement may be amended or waived only with the written consent of both Parties.

**15. Survival**

The provisions of Clauses 4, 6, 8, 9, 10, 11, 12, 13, 14, and 15, shall survive the termination of this Agreement.


